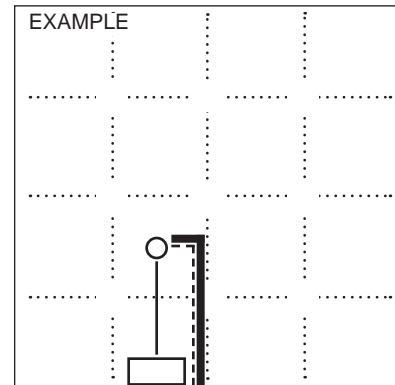

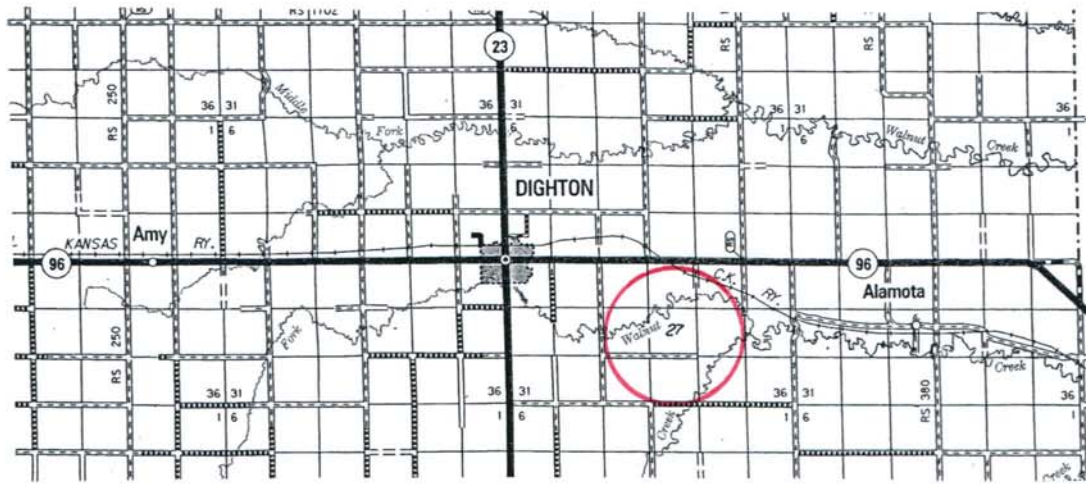
Drillsite Location
