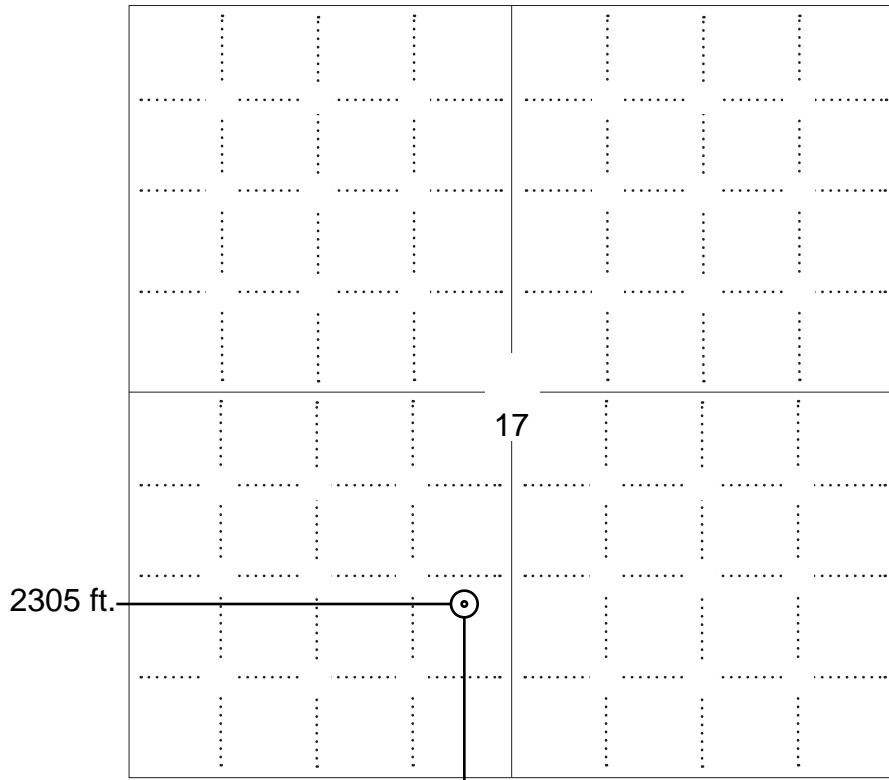

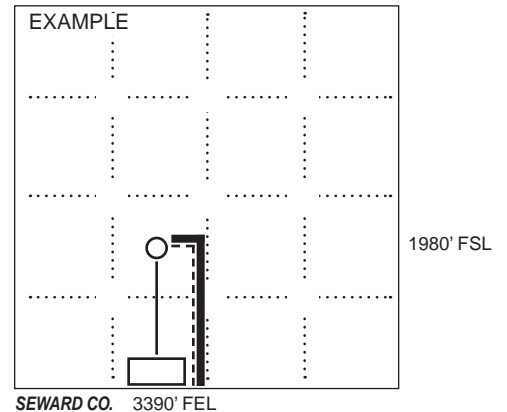

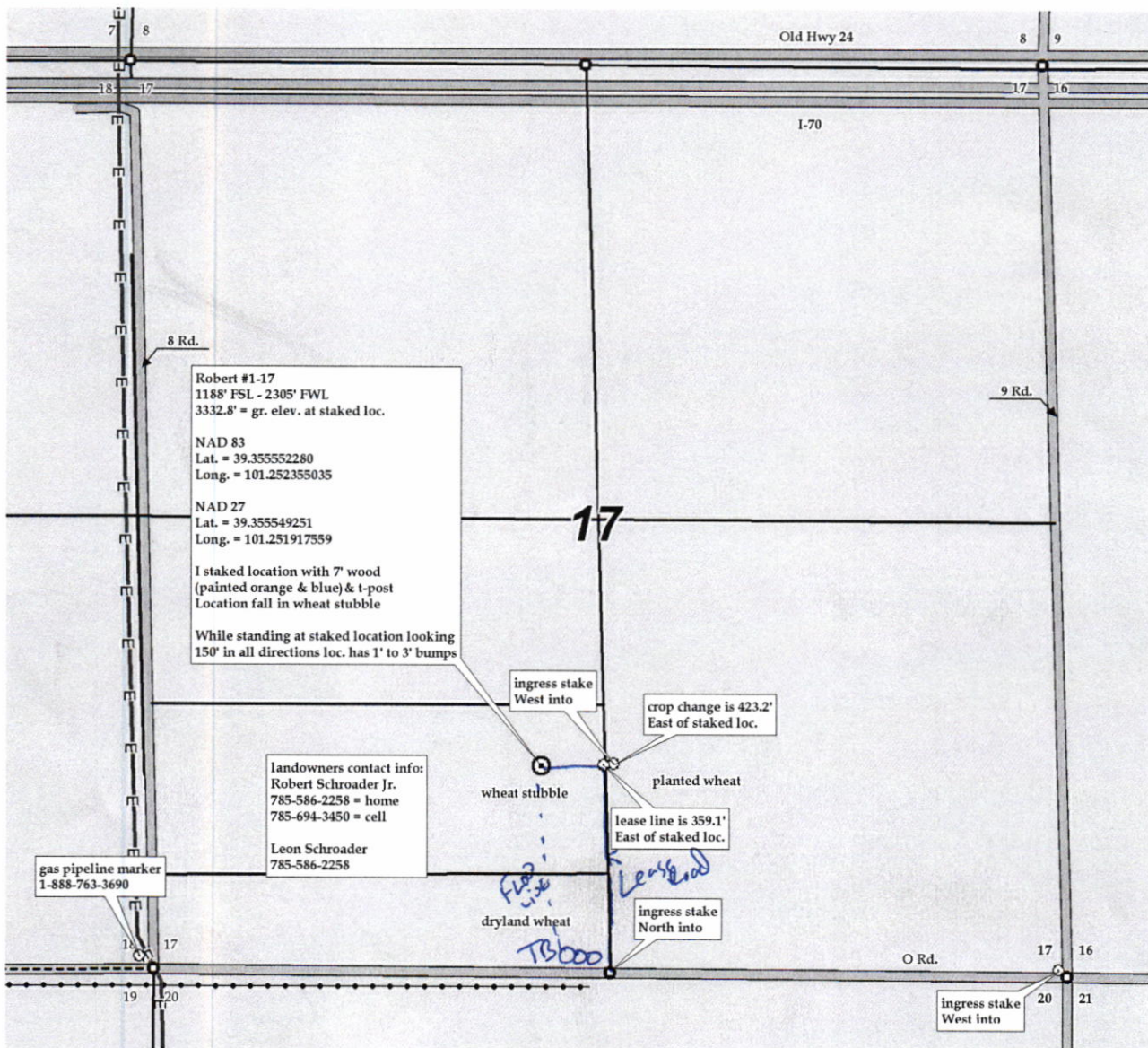

**DIRECTIONS:** From center of Colby, KS at the intersection of Hwy 25 & Hwy 24 – Now go 9 miles West on Hwy 24 – Now go 1 mile South on 11 Rd. – Now go 2 miles West on O Rd. to the SE corner of section 17-8s-35w & ingress stake West into – Now go 0.5 mile West on O Rd. to ingress stake North into – Now go approx. 530' / 0.1 mile North on dryland wheat – Now go approx. 660' / 0.1 mile North through wheat stubble to ingress stake West into – Now go 423' West through wheat stubble, into staked location.  
**Final ingress must be verified with landowner or operator.**
