

Your application for Temporary Abandonment (TA) of the above-listed well is denied for the following reasons(s):

In accordance with K.A.R. 82-3-111, this well must be plugged or returned to service by January 21, 2016.

You may file an application for an exception to the 10-year limitation in K.A.R. 82-3-111 to demonstrate why it is necessary to TA the above well for more than (10) years. You must notify the Commission in writting no later than January 21, 2016 of your intention to file the application, and your complete application is due February 20, 2016.
