Casing Pressure Buildup



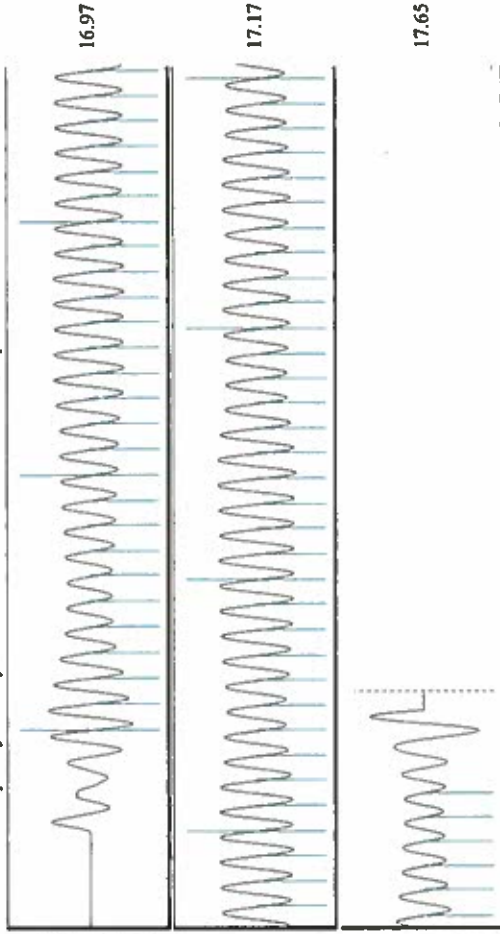
