Your application for Temporary Abandonment (TA) of the above-listed well is denied for the following reasons(s):

**Shut-in Over 10 years**

In accordance with K.A.R. 82-3-111, this well must be plugged or returned to service by April 07, 2016.

You may file an application for an exception to the 10-year limitation in K.A.R. 82-3-111 to demonstrate why it is necessary to TA the above well for more than (10) years. You must notify the Commission in writing no later than April 07, 2016 of your intention to file the application, and your complete application is due May 07, 2016.
