AMENDMENT TO OIL AND GAS LEASES

KNOW ALL MEN BY THESE PRESENTS:

THAT the Oil and Gas Leases recorded in Book 222 at Pages 49, 51 and 53 of the records of the Register of Deeds of Ness County, Kansas, covering the Southeast Quarter (SE/4) of Section 23, Township 19 South, Range 22 West, Ness County, Kansas, is amended by adding thereto the following:
