Plugging Report

- 05-13-16 MI Quality Plus Oilfield Services Rig #2. Pad down. Shut down.
- 05-17-16 RU. POOH with tubing and pump. Warehoused rods onto rack. Started out of hole with tubing. Shut down.
- 05-18-16 POOH with remainder of tubing. Fluid noted on tubing at 1100' from surface. Pumped 80 BSW down casing at 2 BPM on vacuum. Shut down. Obtained plugging orders.
- 05-19-16 RU Swift Services. Pumped 75 sacks (18 barrels) 60/40 Pozmix Cement with 4% gel and 1/4# flocele per sack, mixed with 300# cotton seed hulls, 17 sacks (51 barrels) gelled water, and 105 sacks (25 barrels) cement. Pumped 10 sacks cement down casing annulus. Pressured to 200 psi. Witnessed by Pat Bedore with KO&GCC. RDCT.
