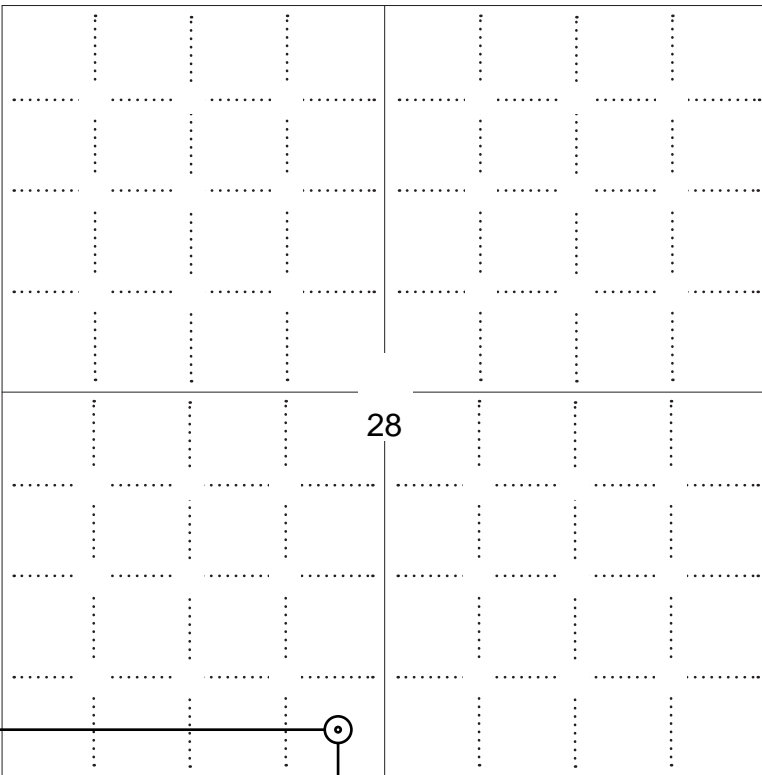

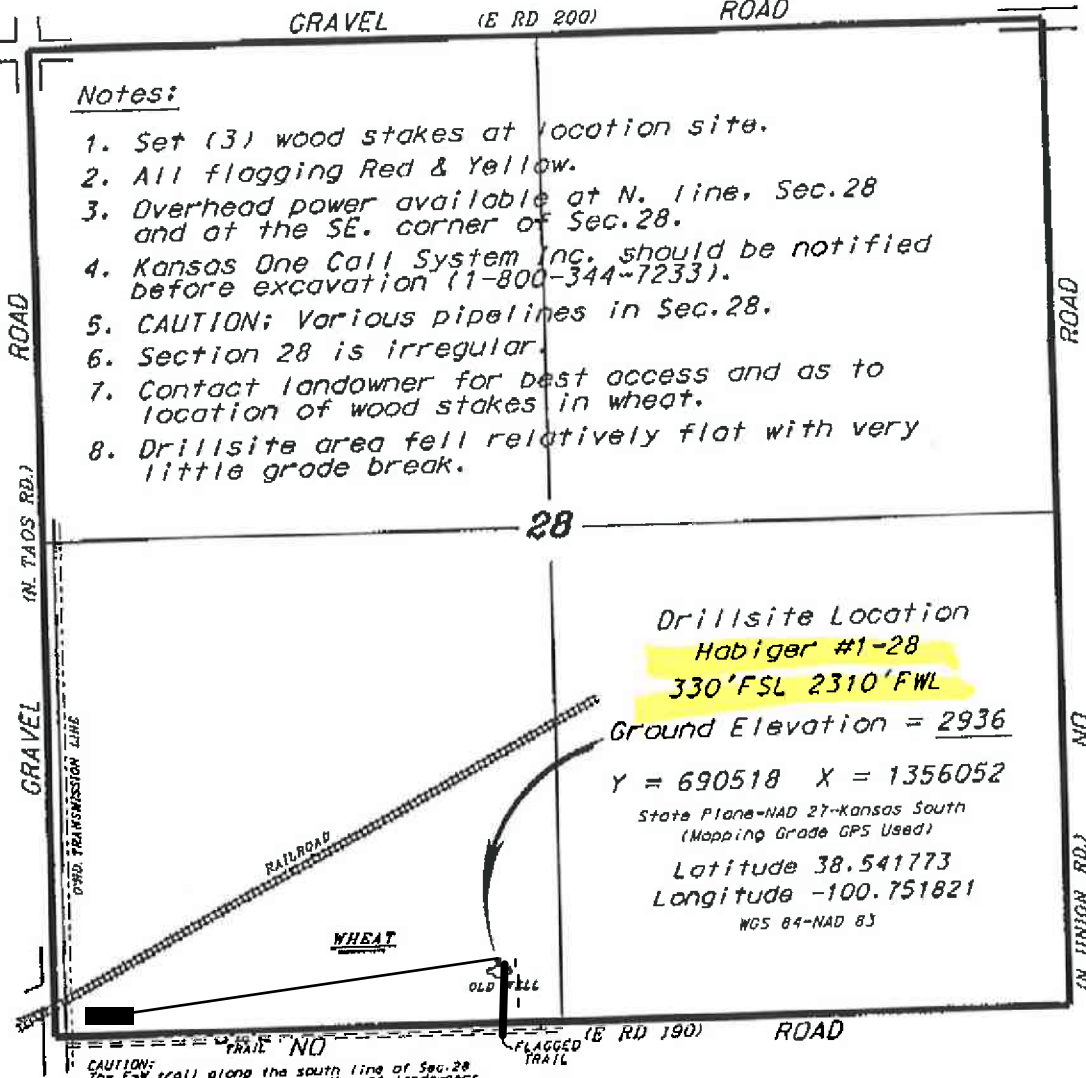

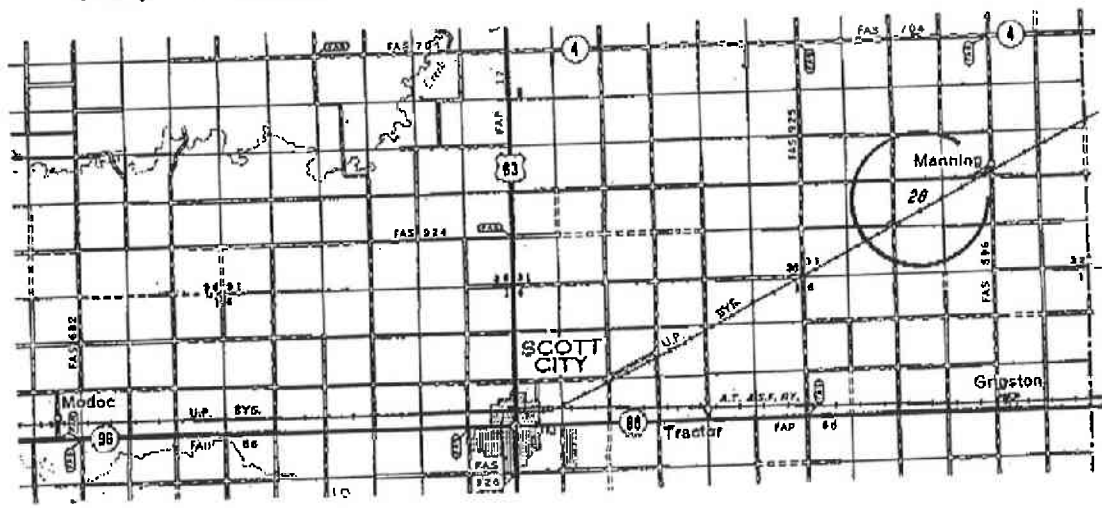
1. Set (3) wood stakes at location site.
