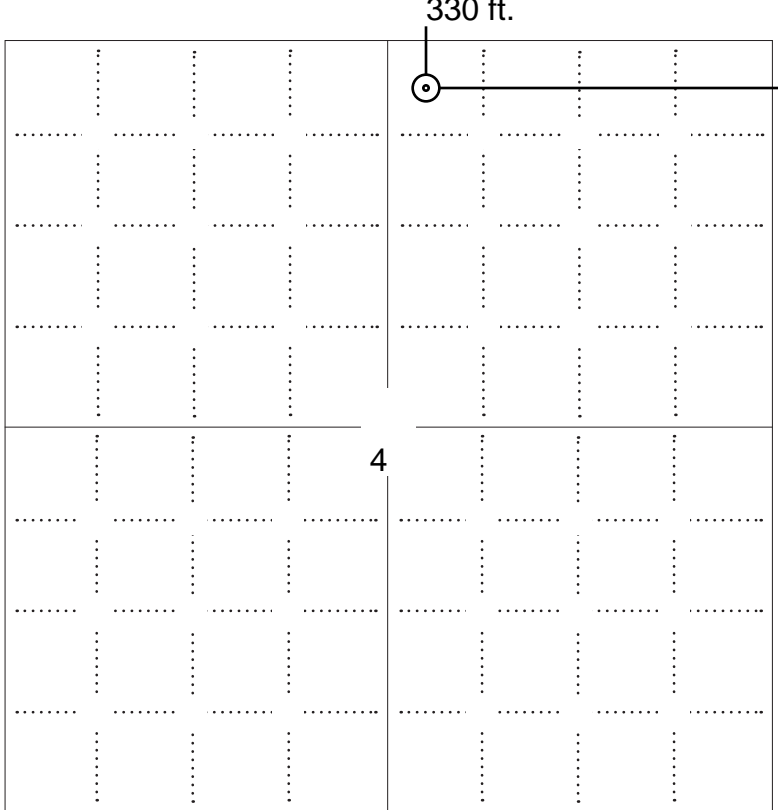

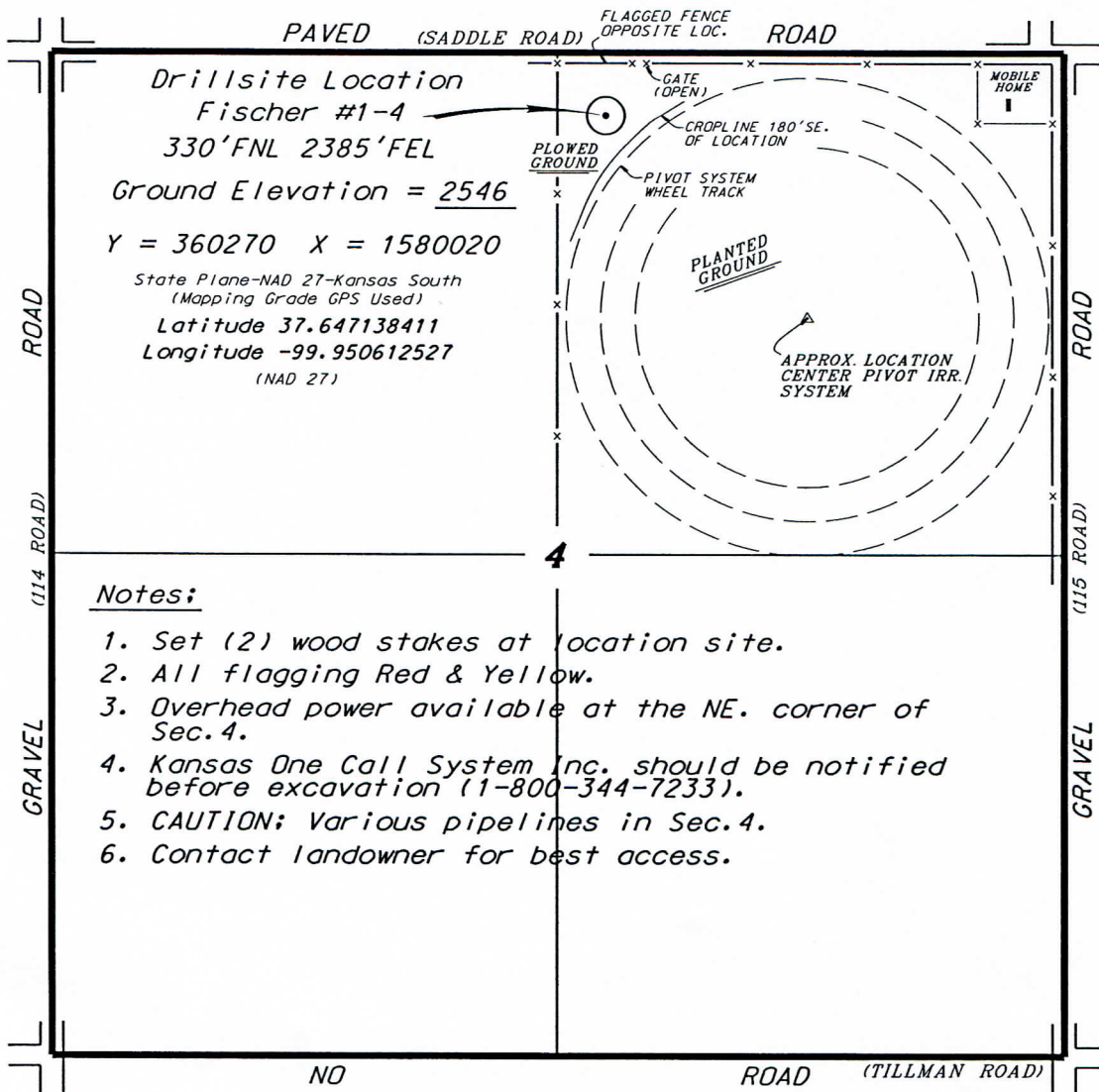

Electrical line



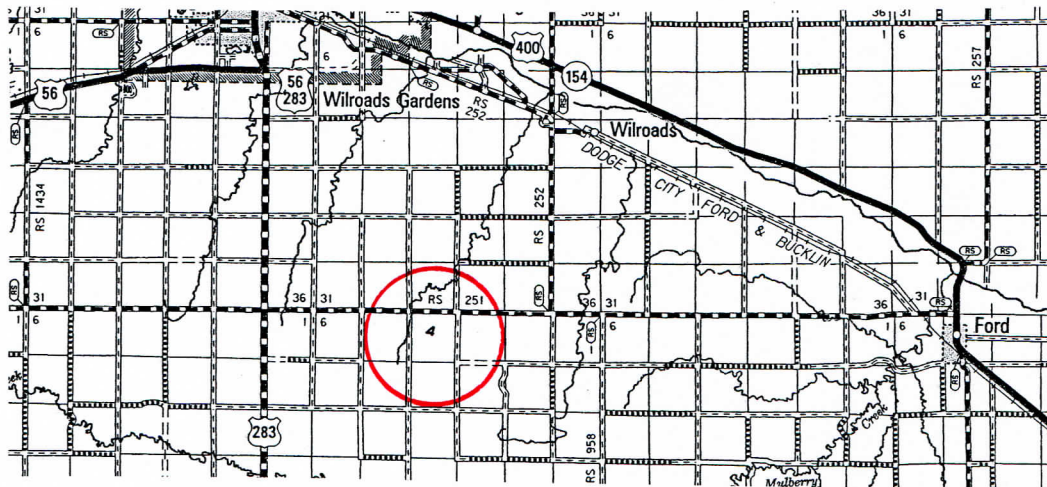
