Pull tubing up to 158', break circulation with fresh water, mixed cement till we got good returns. Pull tubing out of well, filled casing back up with cement. Rig up to casing, pumped cement with poor circulation on backside, due to cable tool hole. Mixed cement with 34 Bbls = 205 sacks. shut down, cement fall down hole, lot cement set up and top off next day. Job Complete wash up & tear down "Thank You"</p>
