Casing Pressure Buildup

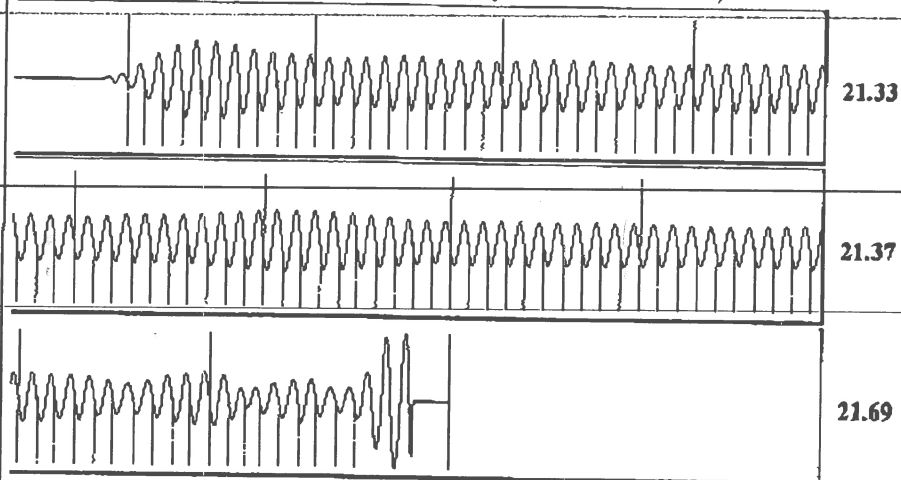
