10. Well History: One foot drilling time was recorded from 2000' to total depth. Ten foot drilling samples were collected from 2000' to total. Drilling samples were examined and sent to the Kansas Geological Society Sample Bureau. A Schlumberger Induction Electrical Log and Microlog Survey was run upon completion of rotary drilling.

11. Remarks:
- (a) There were no shows logged above the Bartlesville
- (b) The Bartlesville had a strong odor with slight scattered staining. There was no free oil in samples. The circulating samples at 3265' had a trace of fresh white chert indicating the top of the Mississippi Chert may have been reached. Log time was approximately 15" from total depth.
- (c) The well had 23' of Bartlesville Sand.

The Conservation Division has received your Well Plugging Application (CP-1).

**Under K.A.R. 82-3-113(b)(2), you must notify DISTRICT 2 of your proposed plugging plan at least 5 days before plugging the well.** DISTRICT 2's phone number is (316) 337-7400. Failure to notify DISTRICT 2, or failure to file a Well Plugging Record (CP-4) after the well is plugged will result in a penalty recommendation.

**Under K.A.R. 82-3-600, you must file an Application for Surface Pit (CDP-1) if you wish to use a workover pit while plugging the well.** Failure to timely file a CDP-1, failure to timely remove fluids, or failure to timely file Closure of Surface Pit (CDP-4) or Waste Transfer (CDP-5) forms will result in a penalty recommendation.

This receipt does NOT constitute authorization to plug this well if you do not otherwise have the legal right to do so.

This receipt is VOID after October 12, 2017. If the well is not plugged by then, you will have to submit a new CP-1 if you wish to plug the well.

**The October 12, 2017 deadline does NOT override any compliance deadline given to you by Legal, District, or other Commission Staff.** Failure to comply with any given deadline will still result in the Commission assessing penalties, or taking other legal action.
