It also had a casing leak later from 476'-508' and was squeezed with 150 sacks of cement. Cement circulated to the top of the 8 5/8 x 5 1/2 annulus the job was done 1-23-2001 Allied ticket # 5122

I talked to Bruce Redie a week ago about what it would take to plug the well. If you can't do it for a year we would like to plug it this summer.
