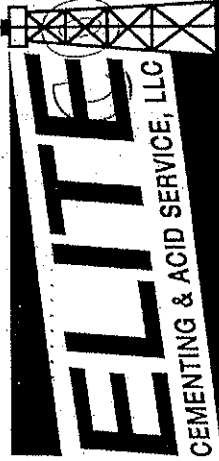

Remarks: Safety Meeting: Rig up to 85% casing. Break circulation w/ 5 BBL fresh water. Mixed 145 sts class A. Cement w/ 3% Cacke, 14 # Flo-Seal /sk @ 15.2 #/gal, yield 1.18 = 31 BBL slurry. Displace w/ 13.7 BBL fresh water. Shut casing in. 1 BBL Cement slurry to pit. Job complete. Rig down.

Note: Last 5 BBL of Displacement we had very little fluid returns to surface. Wait 1 Hr on location after job was complete, cellars standing full of cement
