District staff has inspected the above referenced location and has determined that the Workover pit shall be constructed **without slots**, the bottom shall be flat and reasonably level, and the free fluids must be removed. The fluids are to be removed from the Workover pit within 72 hours of completion of drilling operations.

NO completion fluids or non-exempt wastes shall be placed in the Workover pit.
