Till we got good cement returns / mixed with 14.5 Bbls water = 88 SKs 60/40 Pozmix w/ 4% Gel + 40 lbs Hulls  
Pull Tubing out of well, filled casing back up with cement, rig up to casing - squeezed cement into well  
Shut down with 350 psi, well holding 300 psi - closed casing in with 300 psi > mixed w/ 2 1/2 Bbls = 15 SKs cement  
Plug solid from 938' to surface with 103 sacks 60/40 Pozmix cement w/ 4% Gel + 2% CaCl2
