District staff has inspected the above referenced location and has determined that an unsealed condition will present a pollution threat to water resources.

District staff has recommended that the Workover pit be lined with bentonite or native clay, constructed <u>without slots</u>, the bottom shall be flat and reasonably level and the free fluids removed after drilling operations have ceased.

### NO completion fluids or non-exempt wastes shall be placed in the Workover pit.
