

The requirements may include any of the following:  (A) Burial in place, in accordance with the grading and restoration requirements in K.A.R. 82-3-602 (f);  (B) removal and placement of the contents in an on-site disposal area approved by the commission;  (C) removal and placement of the contents in an off-site disposal area

lease	acreage owned by the same landowner or to another producing	
	or unit operated by the same operator, if prior written permission	
from	the landowner has been obtained; or	

	(D)	removal of the contents to a permitted off-site disposal area

(b)	Each	violation of this regulation shall be punishable by the following:
