Dear Mr. and Mrs. Dwyer:

Kelso Oil & Gas, Inc. ("Buyer"), hereby offers to purchase all of the right, title and interest of Paul Dwyer and Lindi Dwyer, Joint Tenants with Rights of Survivorship ("Seller"), in and to the oil and gas leases, production, personal property, equipment and contract rights in the captioned well and lands (collectively, the "Property"), more fully described on the attached Exhibit 'A', subject to the following terms and conditions:

1. The purchase price of the Property is \$525,000.00, payable at closing for conveyance of all of Seller's right, title and interest in the Property. Said Property and all associated equipment will be conveyed to Buyer in their present condition and location on an as-is and where-is basis.
2. The effective date of the proposed transaction is 8:00 a.m., C.S.T., on February 2, 2018.
3. Closing for the transaction contemplated herein shall take place in the offices of the Seller on or before February 28, 2018, or as soon as practicable thereafter or by other arrangements made by mutual agreement between Buyer and Seller.

Seller, at closing, shall deliver executed and acknowledged conveyances of the property on the form attached hereto as Exhibit 'B' executed in favor of Buyer, file the Change of Operator form (KCC form T-1) on KOLAR naming Mike Kelso Oil, Inc. as operator of the associated wells and turn

over possession of the property to Buyer. Operations of the Property will not be taken over and effective until such time as the KCC has approved the T-1 form accepting Mike Kelso Oil, Inc. as the operator of record.

At, or within ten (10) days after closing, Seller will deliver to Buyer, its land, legal, well, log and engineering files related to the Property.

4. This offer is subject to (i) Buyer's verification of working and net revenue interests, and the acceptability of associated titles; (ii) verification that there are no material claims, liens or encumbrances against the Properties and that Seller can convey merchantable title to the Property.
5. All claims and liabilities, arising prior to, or as a result of incidents prior to the effective date, including environmental liabilities, shall be the responsibility of the Seller and Seller shall indemnify Buyer against such claims and liabilities. All claims and liabilities arising after, and due to incidents after the effective date, shall be the responsibility of the Buyer and Buyer shall indemnify Seller against such claims and liabilities.
6. Buyer and Seller hereby agree that all oil sold on or before February 2, 2018 will be credited to the account of Seller and Buyer agrees to notify the oil purchaser that the change in ownership for the purpose of oil sales will be effective March 1, 2018. All other oil on stock will become the property of the Buyer.
7. Seller will be responsible for payment of property taxes for 2017 and all prior years. Property taxes for 2018 will be the responsibility of the Buyer.
8. Execution by Seller and delivery at closing of the enclosed Assignment, Bill of Sale and Conveyance in favor of the Buyer.
9. This agreement shall be binding on the parties hereto and their respective successors and assigns.
10. Seller hereby agrees to clean up the existing storage yard (NE/4 Sec. 20-T1S-R32W) and remove all tanks, tubing, rods and any other surplus equipment.



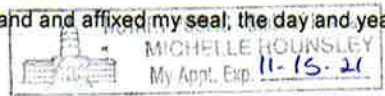
