Plugging Procedure for the D.E. Stout Gas Unit 2

Section 3-34S-40W

Morton County, Kansas

API # 15-129-20427-00-00

Tubing stuck at approximately 1980' to 2100', figured by stretch.

Top of rods at 2125'.

Glorietta approximately 1230 to 1380'.

Anhydrite approximately 1658'.

Proposed plugging method.

Find free point on tubing and recover as much as possible. Run good tubing down to top of fish and pump 100 sxs cement with hulls. Wait at least 1 hour and tag cement. If cement above 1230', run bond log showing top of cement. If TOC is at 1000' as reported behind production casing, load hole and pressure test casing. Then perforate at 650', run tubing and circulate cement to surface inside and out from 650'. Pull tubing and top off as needed. Tie on back side and finish off with cement.

This is a general guideline. This procedure could change depending on what happens during the plugging of the well.

Dear Katherine McClurkan:

The Conservation Division has received your Well Plugging Application (CP-1).

Under K.A.R. 82-3-113(b)(2), you must notify DISTRICT 1 of your proposed plugging plan at least 5 days before plugging the well. DISTRICT 1's phone number is (620) 682-7933. Failure to notify DISTRICT 1, or failure to file a Well Plugging Record (CP-4) after the well is plugged will result in a penalty recommendation.

Under K.A.R. 82-3-600, you must file an Application for Surface Pit (CDP-1) if you wish to use a workover pit while plugging the well. Failure to timely file a CDP-1, failure to timely remove fluids, or failure to timely file Closure of Surface Pit (CDP-4) or Waste Transfer (CDP-5) forms will result in a penalty recommendation.

This receipt does NOT constitute authorization to plug this well if you do not otherwise have the legal right to do so.

This receipt is VOID after August 02, 2018. If the well is not plugged by then, you will have to submit a new CP-1 if you wish to plug the well.

The August 02, 2018 deadline does NOT override any compliance deadline given to you by Legal, District, or other Commission Staff. Failure to comply with any given deadline will still result in the Commission assessing penalties, or taking other legal action.
