## BILL OF SALE

**KNOW ALL MEN BY THESE PRESENTS**, that, effective March 1, 2018 ("Effective Date"), and in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, **MID-CONTINENT ENERGY OPERATING COMPANY**, 2111 S. Atlanta Place, Tulsa, OK 74114, ("Seller"), does hereby grant, assign, bargain, sell, transfer, deliver and release unto **NORSTAR PETROLEUM INC.**, 88 Inverness Circle E, Unit F104, Englewood, CO 80112-5514, ("Purchaser"), subject to the terms of that certain Letter Agreement, dated February 21, 2018, between Seller and Purchaser, all of Seller's right, title and interest in and to all of the wellbore, surface equipment, downhole equipment, fixtures and related inventory, including all personal property of whatsoever nature ("Subject Property"), whether individually or properly described in Exhibit "A", attached hereto, used in connection with the **Hineman Unit #1-6 well**, (the "Well"), all of which are located on the following described lands in **Lane County, Kansas**, (the "Lands"), to-wit:

**Township 19 South, Range 28 West**  
**Section 6: NE/4NW/4NE/4NW/4**

Seller hereby covenants that it is the lawful owner of Subject Property and the Well and has the right to sell 100% of the Subject Property and the Well. Seller claims that the Subject Property and the Well are free and clear from all encumbrances. Both Seller and Purchaser acknowledge that they may own and operate other wells in the area and that the sale of the Subject Property and the Well hereunder will in no way interfere with the operations of the other wells located on lands adjacent to or within the vicinity of the Lands.

This Bill of Sale is delivered by Seller without warranty of title, express or implied. The Subject Property and the Well are sold and conveyed "**AS IS, WHERE IS**", and Seller expressly disclaims all express or implied warranties with respect thereto, including, without limitation, any implied warranty of merchantability or fitness for a particular purpose or any warranty of title. Seller agrees to indemnify and to hold Purchaser harmless from all losses and liabilities relating to Seller's use of the Subject Property and the Well, *before* the Effective Date of this Bill of Sale, and Purchaser agrees to indemnify and to hold Seller harmless from all losses and liabilities relating to Purchaser's use of the Subject Property and the Well, *after* the Effective Date.

Purchaser recognizes that the Well, located on the Lands, is currently shut-in and temporarily abandoned and that Seller hereby sells the Well and the Subject Property to Purchaser in exchange for Purchaser's takeover of operations in accordance with the rules and regulations of the Kansas Corporation Commission, inclusive of Seller's obligation to plug and abandon the Well, to remove the Subject Property and to restore the condition of the surface of the Lands to the satisfaction of the surface owner. Seller agrees to comply with the requirements of the Kansas Corporation Commission and to prepare any documentation necessary for the transfer of the Well and the Subject Property.

**TO HAVE AND TO HOLD**, all of Seller's right, title and interest in and to the Subject Property and the Well to the Purchaser.

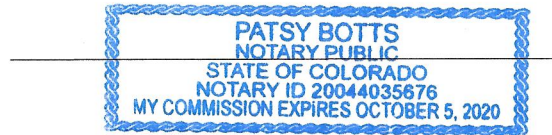
