

Dear Mr. Raney,

The Kansas Corporation Commission (KCC) has received your request dated February 17, 2018 for an exception to the Table 1, Appendix A conductor pipe requirements for the referenced well. From your request, KCC understands that Raney Oil Company, LLC requests an exception to the required installation of 40 to 60 feet (unconsolidated plus 20 feet) of 12" I.D. conductor casing as required in Appendix A of Table 1.

Raney Oil Compay, LLC proposes to set 250' of surface casing. In support of their request, Raney Oil Company, LLC cites wells drilled in the immediate area which have not encountered lost circulation above 250' and have not utilized conductor casing.

After review of this matter by technical staff, an exception is granted to Appendix A, Table 1 Minimum Surface Casing Requirements for the Cully #1-A with the following stipulations:

- A sufficient length of conductor pipe shall be on hand at the drilling site. If unconsolidated material is encountered, conductor pipe shall be installed. If unconsolidated material is not encountered, the minimum required surface pipe shall be installed.
- Surface casing will be set and cemented from 250 feet back to surface prior to any drilling below 260 feet.
- 3. In the event the well is dry and no production pipe has been cemented in-place, plugging will be performed according to KCC rules per KCC District #2 requirements.

District staff has inspected the above referenced location and has determined that an unsealed condition will present a pollution threat to water resources.

District staff has recommended that the reserve pit be lined with bentonite or native clay, constructed <u>without slots</u>, the bottom shall be flat and reasonably level and the free fluids must be removed. The fluids are to be removed from the reserve pit after drilling operations have ceased.

If production casing is set all completion fluids shall be removed from the working pits daily. NO completion fluids or non-exempt wastes shall be placed in the reserve pit.

The fluids should be taken to an authorized disposal well. Please call the District Office at (316) 337-7400 when the fluids have been removed. Please file form CDP-5 (August 2008), Exploration and Production Waste Transfer, through KOLAR within 30 days of fluid removal.
