Procedure:

1. MIRU.
2. Unset packer and POOH w/ 1.9" tubing. RIH w/ 2-7/8" CIBP and set at 5010'.
3. Cut 2-7/8" @ 4500'. PU 2-7/8" and circulate well with 70 bbls of 9.5# Mud and 25 sxs of Class C Cement to cover from 5010'-4400'.
4. Spot 65 sxs of Class C Cement to cover from 3590'-2655'.
5. RIH and cut 4-1/2" @ 1570'. POOH w/ 4-1/2" Casing.
6. Circulate 100 bbls of 9.5# mud and 35 sxs of Class C Cement from 1570'-1465'.
7. Spot 60 sxs of Class C Cement from 550'-350' to protect groundwater.
8. Top out w/ 25 sxs of Class C Cement from 85'-5'.
9. RDMO P&A Rig.
10. Cut of Wellhead and weld cap plate. Cut well anchors.
11. Drag Location.
 - If open pit is dug, then haul fluids and backfill. If steel pit is used haul fluids and MO.

Dear Emily J. Van Der Gryp:

The Conservation Division has received your Well Plugging Application (CP-1).

Under K.A.R. 82-3-113(b)(2), you must notify DISTRICT 1 of your proposed plugging plan at least 5 days before plugging the well. DISTRICT 1's phone number is (620) 682-7933. Failure to notify DISTRICT 1, or failure to file a Well Plugging Record (CP-4) after the well is plugged will result in a penalty recommendation.

Under K.A.R. 82-3-600, you must file an Application for Surface Pit (CDP-1) if you wish to use a workover pit while plugging the well. Failure to timely file a CDP-1, failure to timely remove fluids, or failure to timely file Closure of Surface Pit (CDP-4) or Waste Transfer (CDP-5) forms will result in a penalty recommendation.

This receipt does NOT constitute authorization to plug this well if you do not otherwise have the legal right to do so.

This receipt is VOID after September 29, 2018. If the well is not plugged by then, you will have to submit a new CP-1 if you wish to plug the well.

The September 29, 2018 deadline does NOT override any compliance deadline given to you by Legal, District, or other Commission Staff. Failure to comply with any given deadline will still result in the Commission assessing penalties, or taking other legal action.
