Dear R. A. (Dick) Schremmer:

District staff has inspected the above referenced location and has determined that an unsealed condition will present a pollution threat to water resources.

District staff has recommended that the Workover pit be lined with bentonite or native clay, constructed <u>without slots</u>, the bottom shall be flat and reasonably level and no deeper than 4 feet. The free fluids must be removed. The fluids are to be removed from the Workover pit after drilling operations have ceased.

NO completion fluids or non-exempt wastes shall be placed in the Workover pit.

The fluids should be taken to an authorized disposal well. Please call the District Office at (316) 337-7400 when the fluids have been removed. Please file form CDP-5 (August 2008), Exploration and Production Waste Transfer, through KOLAR within 30 days of fluid removal.
