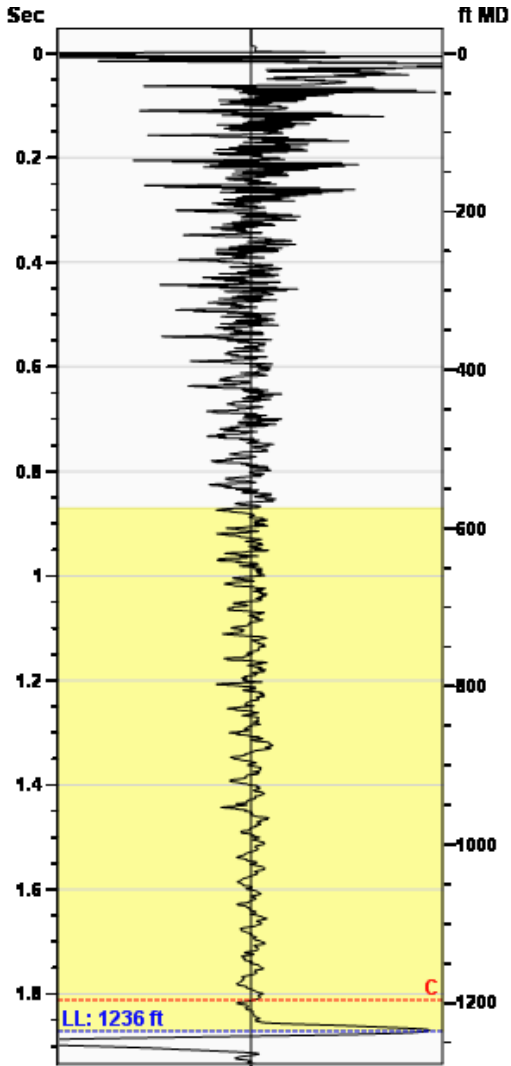

Liquid Level

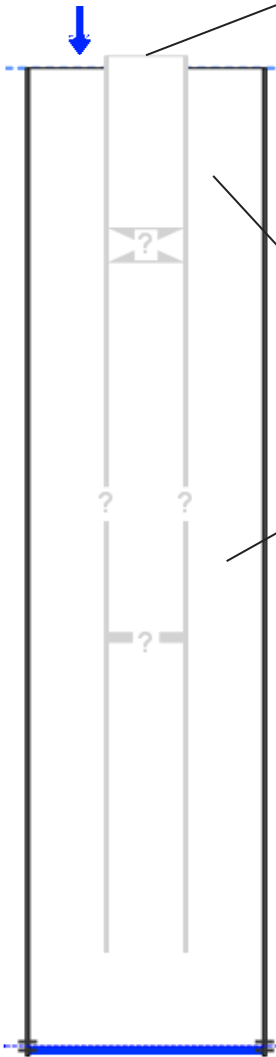

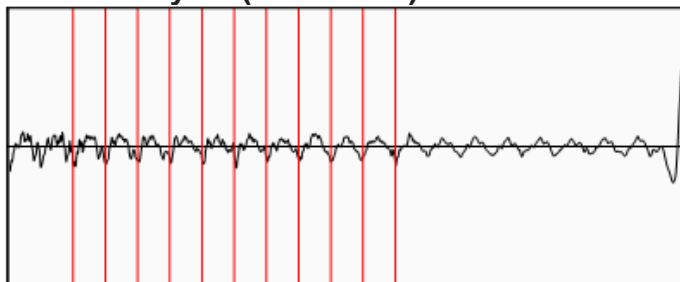

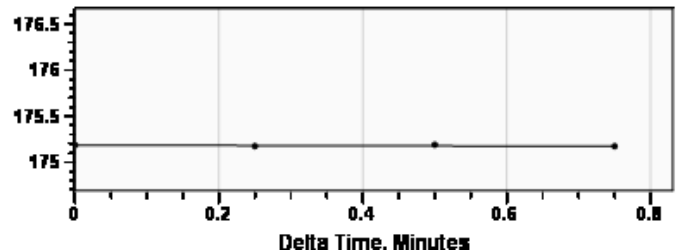
