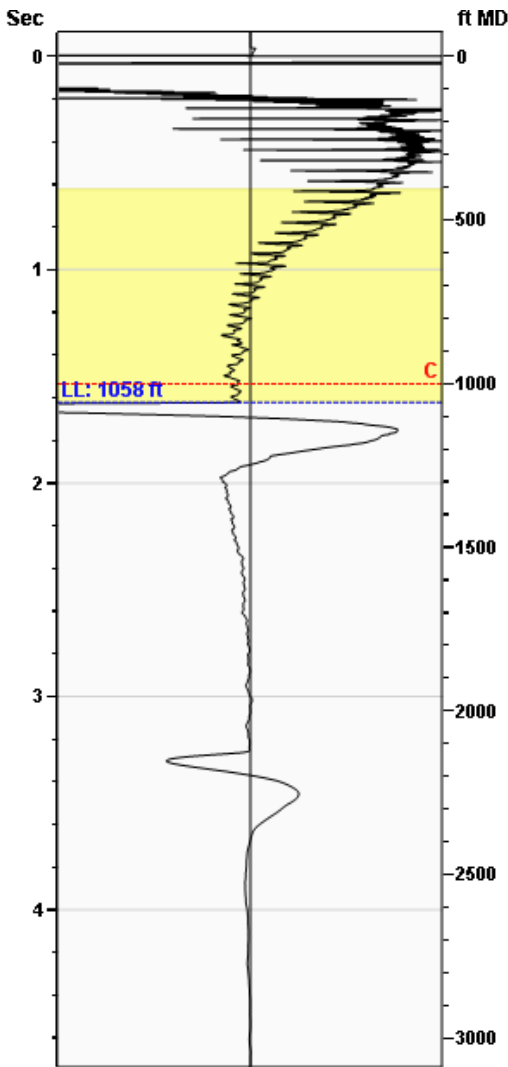

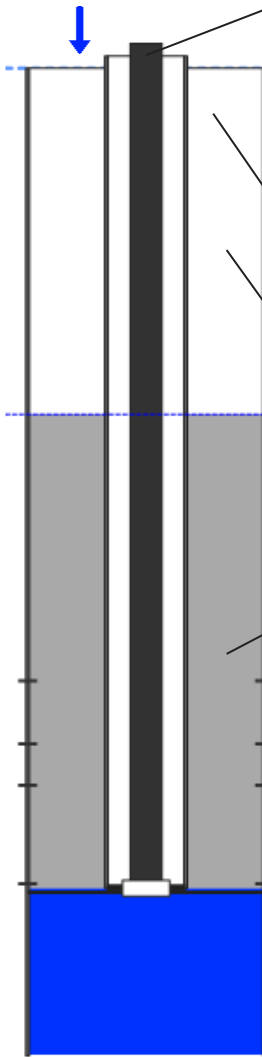


Liquid Level 1058 ft MD

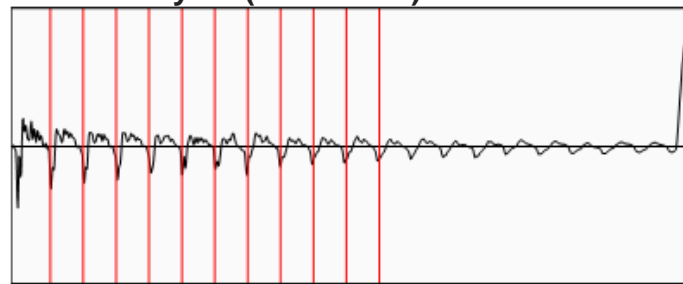

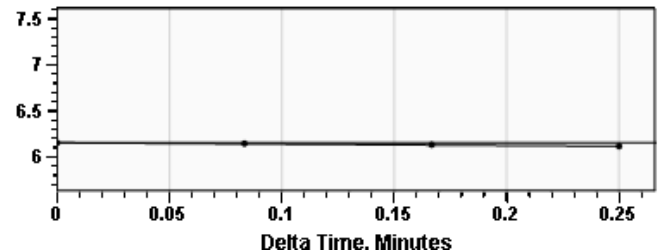
