WHEREAS, **Indian Oil Co, Inc., at 308 S Main St., Medicine Lodge, KS 67104**, hereinafter called “**Purchaser**” desires to buy all or a part of the leasehold interest in and to the above leases, as further agreed herein;

NOW THEREFORE, the undersigned parties hereto (“**Parties**”), enter into this Agreement (“**Agreement**”) which shall be as follows:

1. For and in consideration of **Purchase Price** agreed upon separately for each of the above **Leases**, as negotiated between **Purchaser** and **Operator** with reference to 100% Working Interest value, and other valuable consideration, the receipt of which is hereby acknowledged, **Operator** does hereby sell, quitclaim, assign, transfer and set over unto **Purchaser** all of its working interest in and to said **Leases**, together with the equipment thereupon, or obtained in connection therewith, but without any warranty of title or condition, express or implied. This Assignment is subject to outstanding overriding royalty and other instruments of record, and effective December 1, 2018.
2. **Operator** represents that it has obtained assignments of working interest from parties who are believed to had owned, prior to said assignments, 5/6 share of the undivided 100% WI in each of the above **Leases**. Said assignments are recorded in Book 479 Pages 72-73 and 77-78 in Pratt County Register of Deeds. With respect to the remaining 1/6 working interest previously owned by **F & P Properties, LLC**, **Operator** is in possession of the original assignment of oil and gas leases from **F & P Properties, LLC** to **Operator** which has not been placed of record. It shall be placed of record together with, but immediately before this **Assignment and Bill of Sale**. **Operator** does hereby quitclaim and convey interest so acquired unto **Purchaser**, without any additional reservations, in “as is” condition.
3. **Purchaser** agrees to pay **Operator** by cashier’s check, or a check written on a mutually agreed upon bank, at closing, the **Purchase Price** for both leases as to 100% working interest, notwithstanding the actual amount of interest conveyed as of this date.

4. Time is of the essence for the purpose of this **Agreement**. Upon closing, which shall be attempted to take place before December 1, 2018, **Operator** and **Purchaser** shall immediately file the Operator Transfer form with KCC to transfer operations on all of **Operator's** wells subject to the above **Leases**.
5. **Operator** hereby informs **Purchaser** of the fact that shut in gas rental payments have been made to the mineral owners of **Curry-32** lease, the receipt of which has been acknowledged by the latter owners.
6. This **Agreement** represents the final understanding between the **Parties**, which supersedes all previous agreements, verbal or written, pertaining to the matter thereof. It shall be binding upon said **Parties**, their successors, assigns and legal representatives.
