AFFIDAVIT

The undersigned hereby affirms that the drilling, completion and eventual plugging of this well will comply with K.S.A. 55 et. seq.

It is agreed that the following minimum requirements will be met:

1. Notify the appropriate district office **prior** to spudding of well;
2. A copy of the approved notice of intent to drill **shall be** posted on each drilling rig;
3. The minimum amount of surface pipe as specified below **shall be set** by circulating cement to the top; in all cases surface pipe **shall be set** through all unconsolidated materials plus a minimum of 20 feet into the underlying formation.
4. If the well is dry hole, an agreement between the operator and the district office on plug length and placement is necessary **prior to plugging**;
5. The appropriate district office will be notified before well is either plugged or production casing is cemented in;
6. If an ALTERNATE II COMPLETION, production pipe shall be cemented from below any usable water to surface within **120 DAYS** of spud date. Or pursuant to Appendix "B" - Eastern Kansas surface casing order #133,891-C, which applies to the KCC District 3 area, alternate II cementing must be completed within 30 days of the spud date or the well shall be plugged. **In all cases, NOTIFY district office** prior to any cementing.

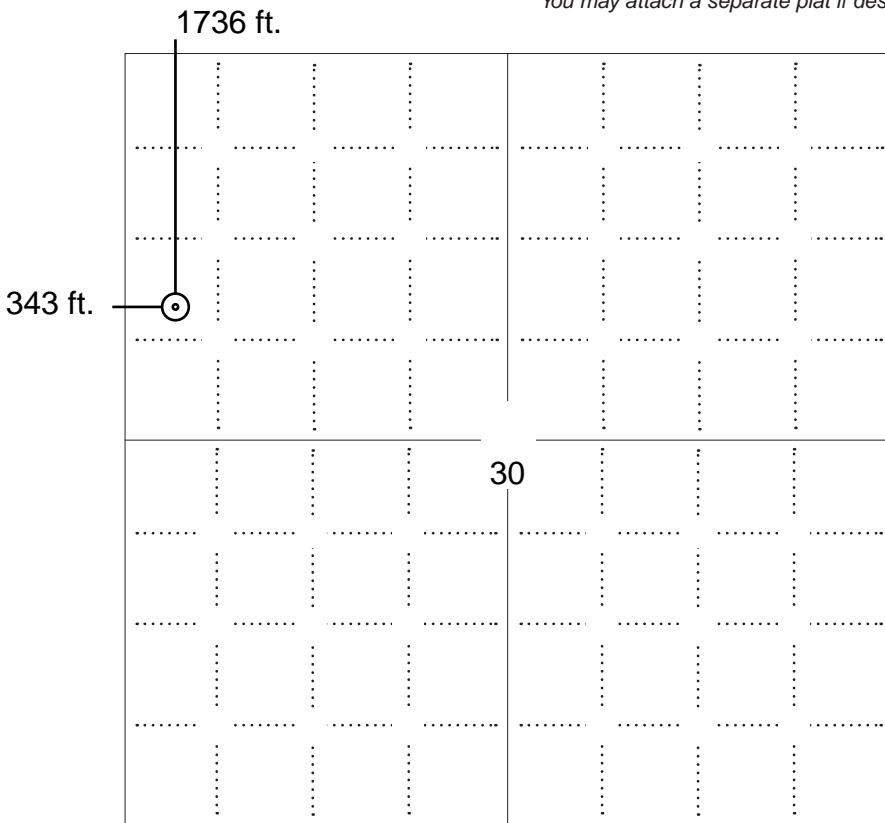

Dear Nicholas Hess:

This is in response to the information we received on August 20th, requesting a Department of the Army (DA) permit determination to drill an oil well by the South Smoky Hill River. The project is located in Section 30, Township 13 south, Range 37 west in Logan County, Kansas.

We have reviewed the information furnished and we have determined that this would not result in the discharge of dredged or fill material into any waters of the United States if the following conditions are met:

1. You must move the Oil well stake/drill hole 80' to the north of the current coordinates from the South Smoky Hill River.
2. The oil well pad must be constructed above the Ordinary High Water Mark and no discharge of fill will be allowed below the Ordinary High Water Mark in the construction of the oil well pad.
3. The oil well pad will have a berm along the South Smoky Hill River to protect it from flooding.
4. Cobalt Energy will contact the Kanopolis Regulatory Office when the oil well pad construction is completed.
5. Sign and complete the Compliance Certification.

However, other Federal, state and/or local permits may be required and you should verify this yourself.

The Corps of Engineers has jurisdiction over all waters of the United States. Discharges of dredged or fill material in waters of the United States, including wetlands require prior authorization from the Corps under Section 404 of the Clean Water Act (33 USC 1344). The implementing regulation for this Act is found at 33 CFR 320-332.

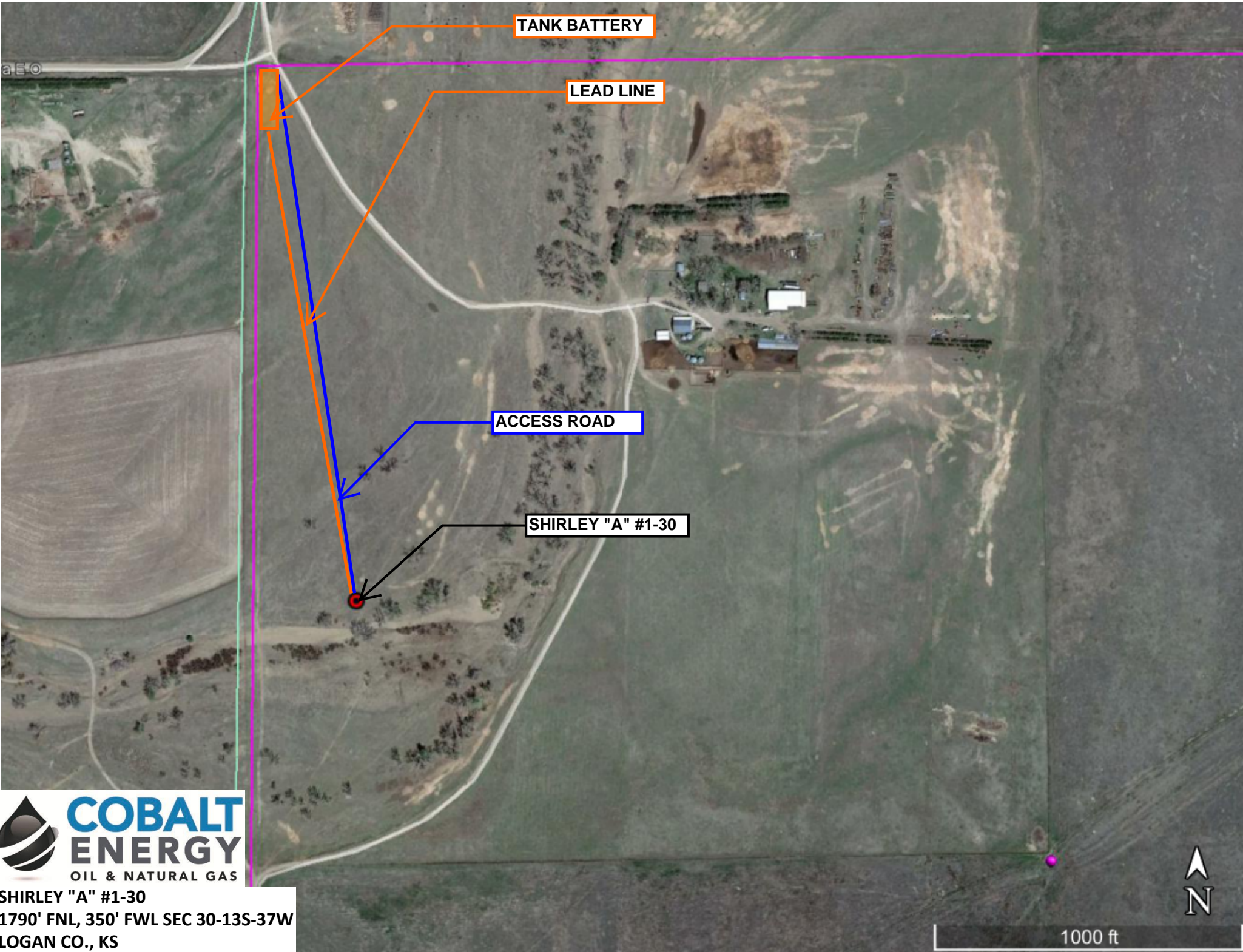

Dear NICHOLAS HESS:

District staff has inspected the above referenced location and has determined that the reserve pit shall be constructed **without slots**, the bottom shall be flat and reasonably level, and the free fluids must be removed. The fluids are to be removed from the reserve pit within 72 hours of completion of drilling operations.

KEEP PITS away from draw/drainage.

If production casing is set all completion fluids shall be removed from the working pits daily. NO completion fluids or non-exempt wastes shall be placed in the reserve pit.

The fluids should be taken to an authorized disposal well. Please call the District Office at (785) 261-6250 when the fluids have been removed. Please file form CDP-5 (August 2008), Exploration and Production Waste Transfer, through KOLAR within 30 days of fluid removal.
