

Your Application for Commingling (ACO-4) for the above described well has been reviewed and approved by the Kansas Corporation Commission (KCC) per K.A.R. 82-3-123. Notice was examined and found to be proper per K.A.R. 82-3-135a. No protest had been filed within the 15-day protest period. This application, which was received by the KCC on December 16, 2013, concerns approval to simultaneously produce from the following sources of supply through the same tubing string in the same wellbore:

Based upon the depth of the Cherokee formation perforations, total oil production shall not exceed **200 BOPD** and total gas production shall not exceed 50% of the absolute open flow (AOF). Production from the well must be adjusted to comply with the allowable limit of **200 BOPD** unless an application for an increased allowable is approved by the commission.

Commingling ID number CO121302 has been assigned to this approved application. Use this number for well completion reports (ACO-1) and other correspondence that may concern this approved commingling.
