Your application for Temporary Abandonment (TA) for the above-listed well is denied for the following reasons(s):

### **Shut-in Over 10 years**

**The Annual U3C reports filed by Operator for 2015,2016,&2017 reflects that the Staatz Schroeder 2-4 has never been returned to service.**

Pursuant to K.A.R. 82-3-111, the well must be plugged or returned to service by May 10, 2018.

If you wish to instead file an application for an exception to the 10-year limitation of K.A.R. 82-3-111, demonstrating why it is necessary to TA the well for more than 10 years, then you must file the application for an exception by May 10, 2018.
