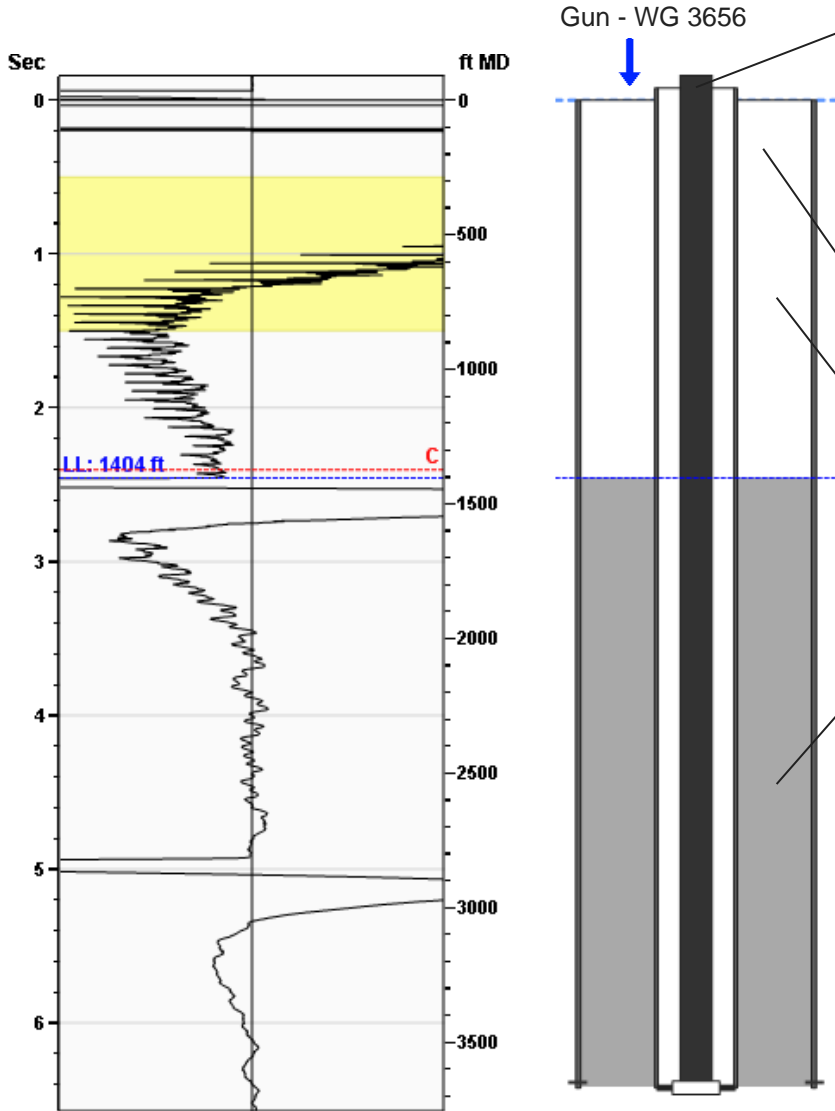

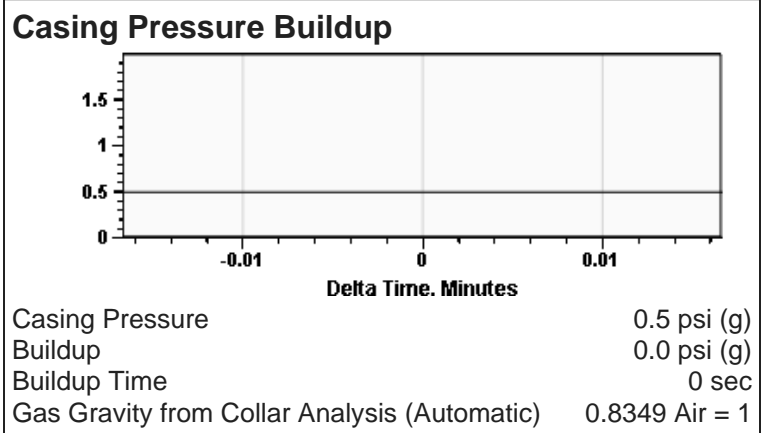
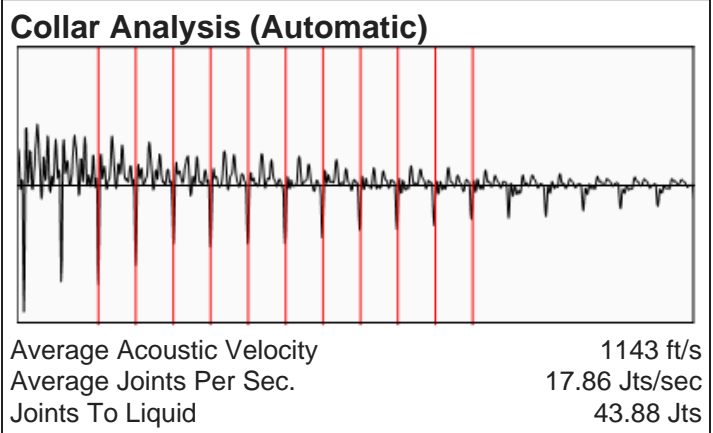


**Liquid Level 1404 ft MD**
