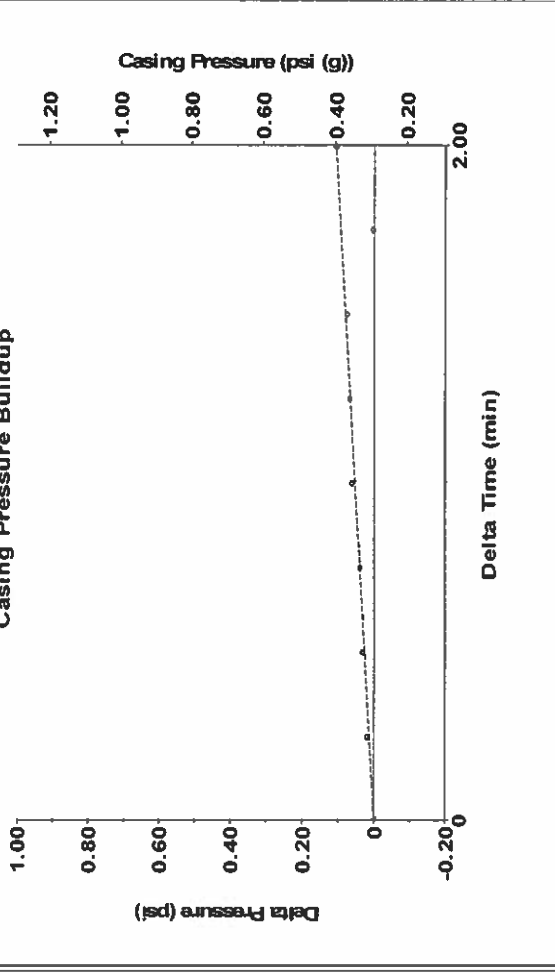

Casing Pressure Buildup



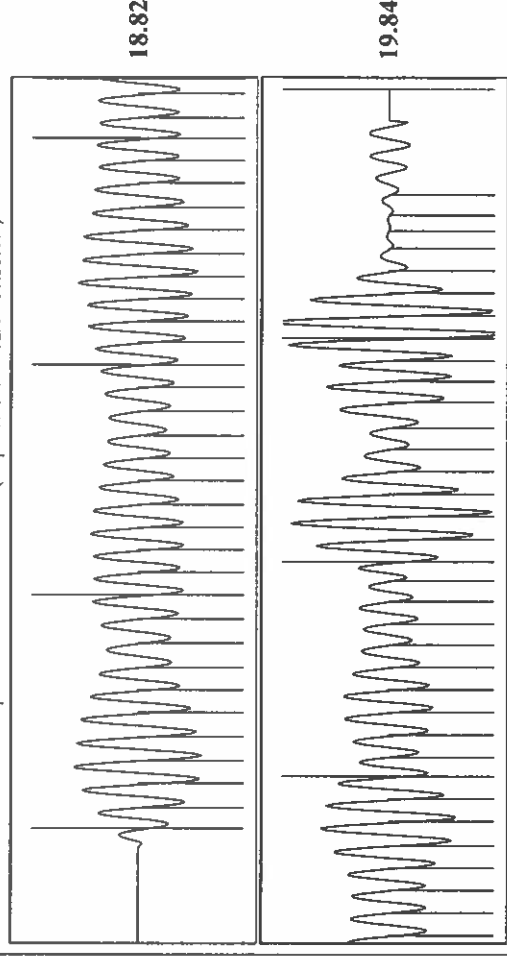
