Jerry Dunkin, Inc., Well Plugging and Services is submitting the following **estimated cost** on the above referenced well. This well will be plugged in accordance with the Rules and Regulations of the Kansas Corporation Commission. It is understood that Sandridge Energy will be responsible for access to and from location and any safety anchors that may be needed, along with any fees or permits that may be required.

Jerry Dunkin, Inc., Well Plugging and Services estimates the cost to plug this well to be \$19,743.00, with JDI retaining all recovered down hole tubulars.

If tubing cut is needed an additional \$2,425.00 per cut will be added to invoice.

If lay down machine is needed it will be added to invoice at actual cost.

Proposed Plugging Procedure

Comanche County, KS
Sec. 6-33S-18W

1. Move in, rig up, blow well down, rig up rod tools, unseat rod pump, pull out of hole with rods and pump, laying down
2. Rig up tubing tools and BOP, release TA, pull out of hole with tubing, standing 1170' in derrick, lay down remainder
3. Rig up Freedom wire line, run in hole with 4 ½" CIBP, set at 5050' with 20' cement, load hole with fluid
4. ND well head to 4 ½" casing, weld on pull sub, free point casing, rig up Freedom wire line, cut casing at 2500' +/-, pull out of hole with casing laying down
5. Run in hole with tubing to 1170', mix and pump 12sx gel, mix and pump 50sx cement from 1170' to 1030' (stone coral plug), pull tubing to 720', mix and pump 50sx cement from 720' to 580' (base of surface), pull tubing to 60', mix and pump 20sx cement from 60' to 4'
6. Dig 8 5/8" casing 4' below ground level, cut off, weld in steel ID plate, cover cellar, rig down, move off location

Dear Laci Bevans:

The Conservation Division has received your Well Plugging Application (CP-1).

Under K.A.R. 82-3-113(b)(2), you must notify DISTRICT 1 of your proposed plugging plan at least 5 days before plugging the well. DISTRICT 1's phone number is (620) 682-7933. Failure to notify DISTRICT 1, or failure to file a Well Plugging Record (CP-4) after the well is plugged will result in a penalty recommendation.

Under K.A.R. 82-3-600, you must file an Application for Surface Pit (CDP-1) if you wish to use a workover pit while plugging the well. Failure to timely file a CDP-1, failure to timely remove fluids, or failure to timely file Closure of Surface Pit (CDP-4) or Waste Transfer (CDP-5) forms will result in a penalty recommendation.

This receipt does NOT constitute authorization to plug this well if you do not otherwise have the legal right to do so.

This receipt is VOID after September 10, 2019. If the well is not plugged by then, you will have to submit a new CP-1 if you wish to plug the well.

The September 10, 2019 deadline does NOT override any compliance deadline given to you by Legal, District, or other Commission Staff. Failure to comply with any given deadline will still result in the Commission assessing penalties, or taking other legal action.
