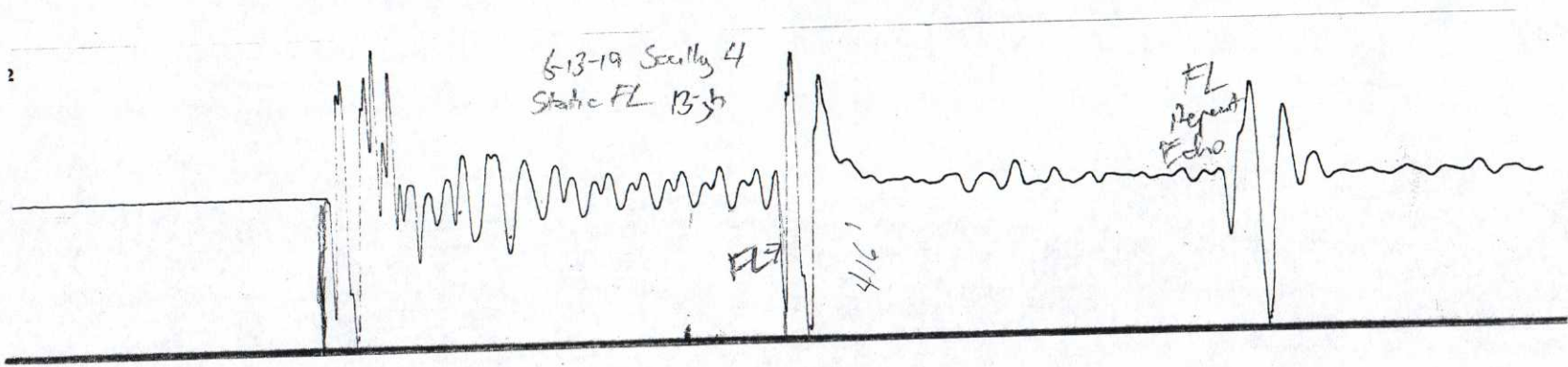



This well has the Viola open only with a plug set on the original Simpson perforations and is a pretty normal fluid level for the Viola in the field after being down for quite awhile. The wells seem to fill up overtime with a pretty high column of oil, such as this.
