Casing Pressure Buildup

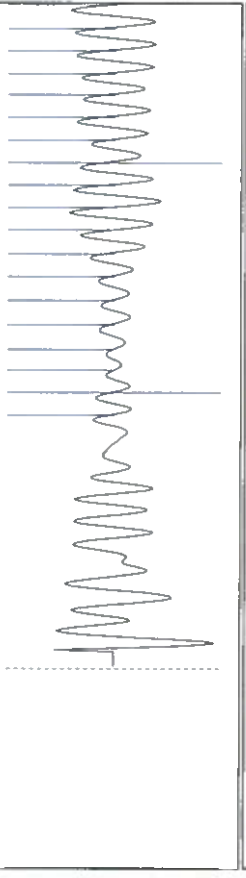
