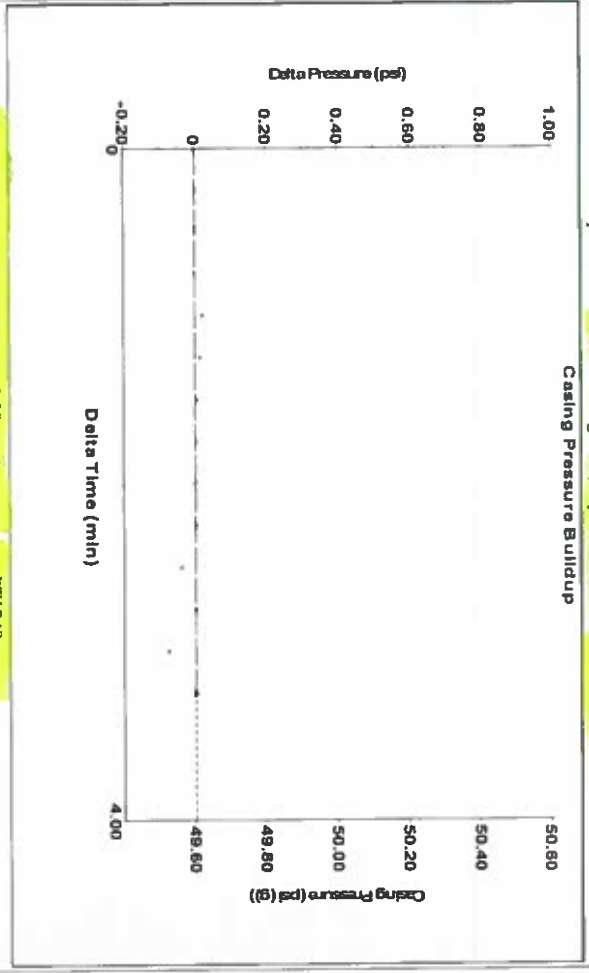


Producing Annular Gas Flow 0 Misc/D

Casing Pressure Buildup

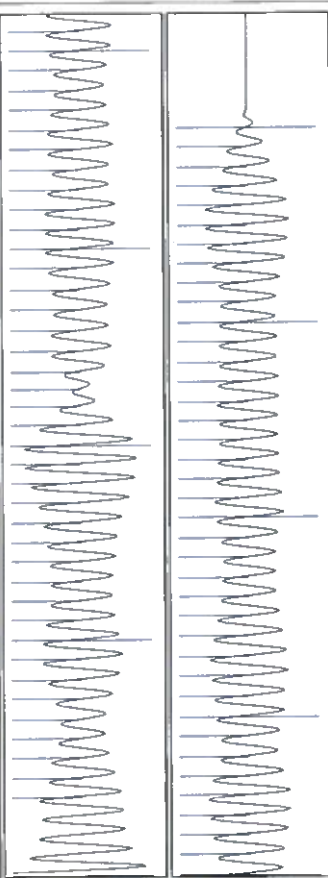
