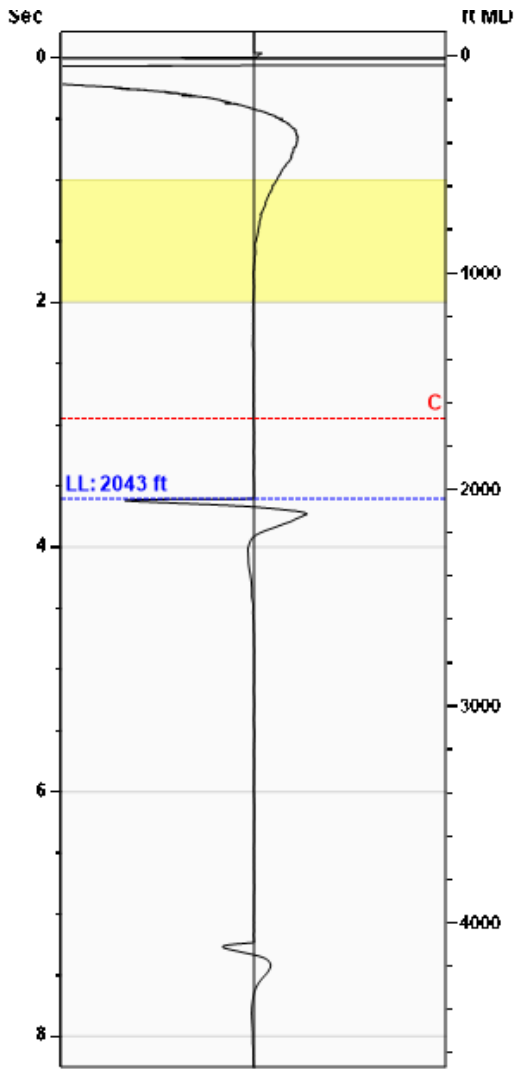

Fluid Above Pump

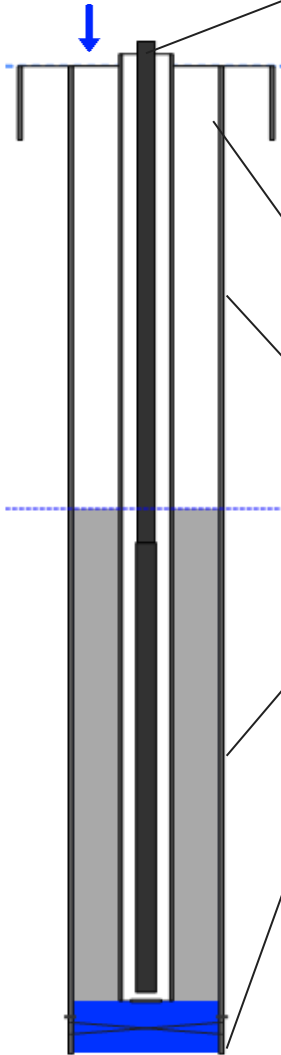

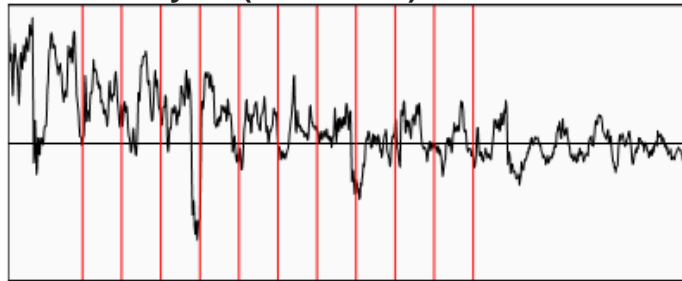
