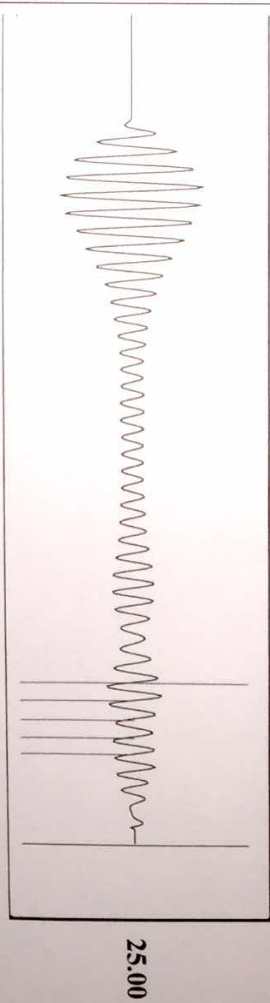


Casing Pressure Buildup
