OIL AND GAS LEASE

THIS AGREEMENT, entered into this 6 day of Jonaghy, 2016 by and between Rebecca Mills, and Ryan Mills, 8804 NE 99th Street Kansas City, MO 64157, hereafter called Lessor, and Potato Creek, LLC, a Kansas limited liability company, 800 4000 Road, Edna, Kansas 67342, hereinafter called Lessee, does witness:

1. That Lessor, for and in consideration of Ten Dollars, in hand paid, receipt of which is hereby acknowledged, and of the covenants and agreements hereinafter contained, hereby grants, leases, and lets unto the Lessee for the purpose of investigating, exploring, prospecting, drilling, mining and operating for and producing oil and gas and their respective constituent products; injecting gas, waters, other fluids, and air into subsurface strata; laying pipe lines, storing oil, building tanks, power stations, roadways, and other structures and things thereon to produce, save, take care of, treat, process, store, transport and market said oil and gas and their respective constituent products, the following described land together with any reversionary rights and after-acquired interests therein, situated in the County of Labette, State of Kansas, described as follows, to-wit:

North Half (N 1/2) of the Northwest Quarter (NW 1/4) of Section Six (6), Township Thirty-five (35) South, Range Twenty (20) East, and containing Eighty (80) Acres, more or less, all in Labette County, State of Kansas.

- 2. This lease shall remain in force for a term of one year from this date and as long thereafter as Lessor receives the Minimum Annual Royalty described in Section 4 of this lease.
- 3. Lessor shall receive a royalty of one-eighth (1/8) of all oil and gas and their respective constituent products produced from said land, free of all expenses relating to the developing, producing, operating, treating, dehydrating, gathering, compressing, or marketing of said oil and gas.
- 4. Minimum Annual Royalty. During each calendar year beginning with the calendar year 2016, Lessee shall pay to Lessor minimum royalties in an amount of One Thousand Five Hundred (\$1,500) Dollars. The Minimum Royalty may be paid in monthly royalty payments calculated under the other sections of this lease or by supplemental cash royalty payments made at any time during the applicable calendar year or a combination of both. If Lessee fails to pay Lessor the minimum royalty on or before the last day of each calendar year, then this lease shall automatically terminate with minimum royalty still being due for the previous year.
- 5. If said Lessor owns a less interest in the above described land than the entire and undivided fee simple estate therein then the royalties herein provided for shall be paid the said Lessor only in the proportion which its interest bears to the whole and undivided fee. However, such royalties shall be increased at the next succeeding lease anniversary after any reversion occurs to cover the interest so acquired.
- 6. The Lessor shall have the right to use, free of cost, gas from any gas well on the leased premises for stoves and inside lights in the principal dwelling house on said land by making its own connections with the well, the use of such gas to be at the Lessor's sole risk and expense.
- The Lessee shall have the right to use, free of cost, gas, oil and water found on said land for its operations thereon, except water from the wells of the Lessor.
- 8. When requested by Lessor, the Lessee shall bury its pipe lines below plow depth.
- No well shall be drilled nearer than 200 feet to any structure on said premises without written consent of the Lessor.
- 10. Lessee shall pay for damage caused by its operations to growing crops on said land.
- 11. Lessee shall have the right at any time during, or after the expiration of, this lease to remove all machinery, fixtures, houses, buildings and other structures placed on said premises by lessee, including the right to draw and remove all casing.
- 12. If the estate of either party hereto is assigned, and the privilege of assigning in whole or in part is expressly allowed, the covenants hereof shall extend to the heirs, devisees, executors, administrators, successors, and assigns, but no change of ownership in the land or in the royalties or any sum due under this lease shall be binding on the Lessee until it has been furnished with either the original recorded instrument of conveyance or a duly certified copy thereof or a certified copy of the will of any deceased owner and of the probate thereof, or certified copy of the proceedings showing appointment of an administrator for the estate of any deceased owner, whichever is appropriate, together with all original recorded instruments of conveyance or duly certified copies thereof necessary in showing a complete chain of title back to Lessor to the full interest claimed, and all
