\*Kansas One Call 3 days prior to move in. Urban O&G test anchors if needed.

1. Move equip to loc. RU e-line, RIH w/ GR & JB to 5,290'. RIH, set CIBP @ 5,290' w/ 2 sks cmt on top. PU, RIH w/ tbg.
2. NU spool and BOP to 5-1/2" bell nipple. PU, RIH w/ 5,300' workstring. RU pump truck and tank trucks, circ w/ 125 bbls mud. TOOH w/ 1,600' tbg, LD remainder of tbg.
3. RU, RIH w/ perf gun. Shoot 4 HPF @ 1,560'. RIH w/ tbg and pkr to 1,250'. M&P 60 sks cmt displ to 1,400'. Release pkr, POOH.
4. Tag cmt if required by KCC. Perf csg @ 500'. RIH, set cmt retainer @ 450'. RIH and sting into retainer. Est rate, M&P 140 sks through retainer to surface out 8-5/8". Unsting and fill 5-1/2" w/ 45 sks cmt to surf. LD and clean tbg.
5. RDWSU. Cut, weld 8-5/8" surf ID. MO loc.

Dear Penny Plumlee:

The Conservation Division has received your Well Plugging Application (CP-1).

**Under K.A.R. 82-3-113(b)(2), you must notify DISTRICT 1 of your proposed plugging plan at least 5 days before plugging the well.** DISTRICT 1's phone number is (620) 682-7933. Failure to notify DISTRICT 1, or failure to file a Well Plugging Record (CP-4) after the well is plugged will result in a penalty recommendation.

**Under K.A.R. 82-3-600, you must file an Application for Surface Pit (CDP-1) if you wish to use a workover pit while plugging the well.** Failure to timely file a CDP-1, failure to timely remove fluids, or failure to timely file Closure of Surface Pit (CDP-4) or Waste Transfer (CDP-5) forms will result in a penalty recommendation.

This receipt does NOT constitute authorization to plug this well if you do not otherwise have the legal right to do so.

This receipt is VOID after May 10, 2020. If the well is not plugged by then, you will have to submit a new CP-1 if you wish to plug the well.

**The May 10, 2020 deadline does NOT override any compliance deadline given to you by Legal, District, or other Commission Staff.** Failure to comply with any given deadline will still result in the Commission assessing penalties, or taking other legal action.
