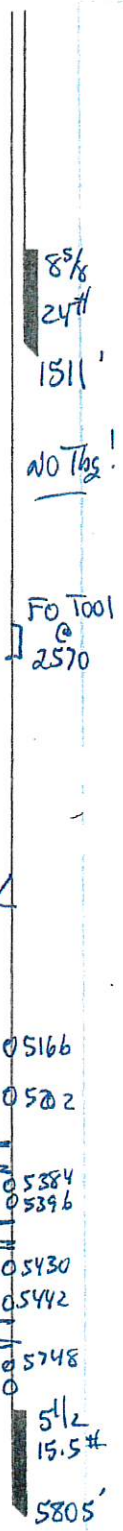

P&A Procedure w/cast

- 1) MIRA spot 2 3/8 work string. NU BOP. TIT w/ 4 tbs @ 71-5166' Circulate w/ 40 bbl mud & spot 40 JKs cement w/ 50# cotton seed hulls. POH & WOC. Tag TOC, 5116' or higher, Circ hole w/ mud.
- 2) Locate EO T @ 3100', spot 20 JKs cement to cover Bad casing. Pull up hole @ 2600' & spot 20 JKs cement to cover FO Tool. POH w/ 4 tbs.
- 3) Ru Wireline track & Pull CBL from 2300' to verify TOC.
- 4A) If TOC above 1511', run tbs @ 1550' & spot 20 JKs to cover 8 5/8 shoe. Cut & pull 5 1/2 csg from 50' above TOC. Run tbs to weeble water & spot 50 JKs @ 64-4 - 20 JKs
- 4B) If TOC below 1511', cut & pull csg. Run tbs @ 5 1/2 steel & spot 80 JKs. Pull up to weeble water, spot 50 JKs Top out 64-4 w/ 20 JKs cement
- 5) ROSU cut & cap well. Dig up rig anchor

Dear Laura Savage:

The Conservation Division has received your Well Plugging Application (CP-1).

Under K.A.R. 82-3-113(b)(2), you must notify DISTRICT 1 of your proposed plugging plan at least 5 days before plugging the well. DISTRICT 1's phone number is (620) 682-7933. Failure to notify DISTRICT 1, or failure to file a Well Plugging Record (CP-4) after the well is plugged will result in a penalty recommendation.

Under K.A.R. 82-3-600, you must file an Application for Surface Pit (CDP-1) if you wish to use a workover pit while plugging the well. Failure to timely file a CDP-1, failure to timely remove fluids, or failure to timely file Closure of Surface Pit (CDP-4) or Waste Transfer (CDP-5) forms will result in a penalty recommendation.

This receipt does NOT constitute authorization to plug this well if you do not otherwise have the legal right to do so.

This receipt is VOID after July 14, 2020. If the well is not plugged by then, you will have to submit a new CP-1 if you wish to plug the well.

The July 14, 2020 deadline does NOT override any compliance deadline given to you by Legal, District, or other Commission Staff. Failure to comply with any given deadline will still result in the Commission assessing penalties, or taking other legal action.
