District staff has inspected the above referenced location and has determined that an unsealed condition will present a pollution threat to water resources.

District staff has recommended that the Workover pit be lined with bentonite or native clay, constructed <u>without slots</u>, the bottom shall be flat and reasonably level.

NO completion fluids or non-exempt wastes shall be placed in the Workover pit.

Fluids removed from the pit should be taken to an authorized disposal well. Please file form CDP-5, Exploration and Production Waste Transfer, through KOLAR within 30 days of fluid removal.
