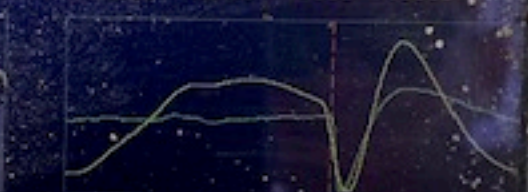

Automatic Liquid Level Depth Analysis

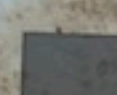
