To Whom it May Concern:

Consistent with communications and negotiations between your company and Trans Pacific Oil Corporation, this letter will set out in written form, the terms and conditions of ARP Operating, LLC's (Buyer) final offer to purchase Trans Pacific Energy Partners LP and other working interest owners' interests (Seller) in the oil and gas leases listed on the attached Exhibit "A". Buyer's purchase offer is as follows:

Purchase Price: \$47,500 payable in total upon closing either by wire transfer or check at Seller's preference for 100% of the working interest in the leases listed on Exhibit "A" attached hereto. Should less than 100% interest be delivered, the purchase price will be adjusted proportionately.

Effective Date of Sale: May 1, 2020

Indemnification: Buyer agrees to indemnify Seller and hold it harmless from all claims, demands, losses, costs, risks or expenses incident to, or resulting from further operations on the leases to be sold for the drilling of additional wells, production of oil or gas, the abandonment and plugging of any well or wells thereon, or the removal of any materials therefrom, from and after the effective date of sale.
