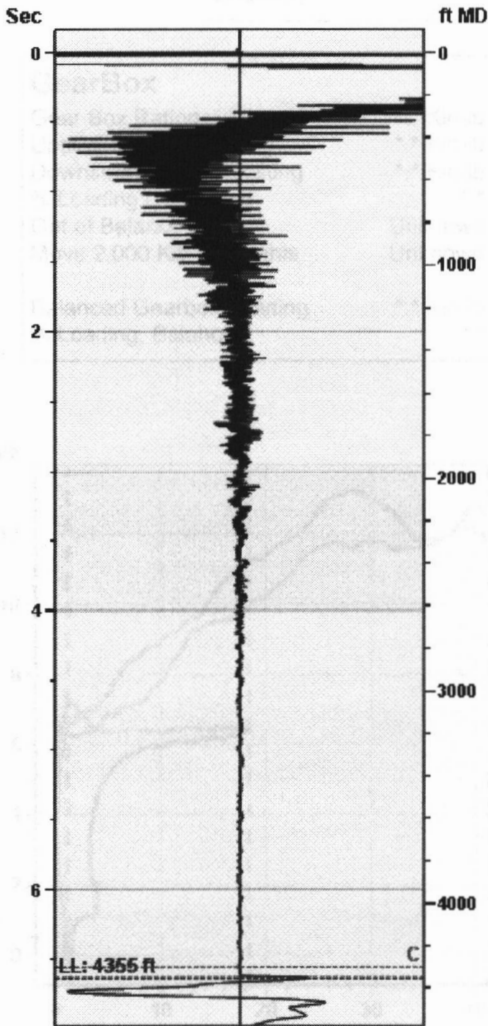


Liquid Level

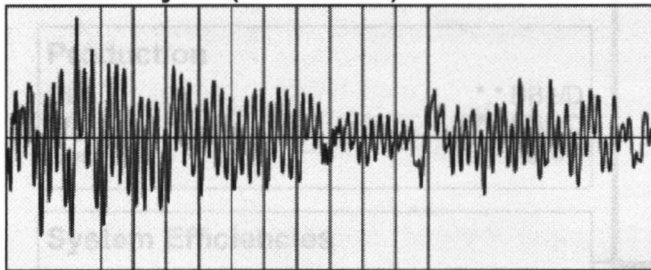

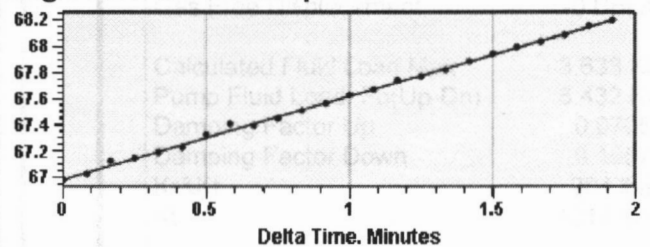
