9/14/20: Drove to location. Tagged plug at 4,050'. Dug cellar and pit. Unpacked casing head. Set floor. Pulled slips. Cut surface off 4' below ground. Ripped casing at 1,840', 1,710'. Came free at 1,710'. Pulled casing to 1,450'. Pumped 35 sacks common cement. Pulled casing out. Drove home.	
9/15/20: Drove to location. Tagged cement at 1,325'. Ran tubing to 1,140'. Pumped 35 sacks cement. Pulled tubing to 600'. Pumped 125 sacks cement to surface. Pulled tubing out. Tore down floor and rig. Emptied pit. Backfilled cellar and pit.
