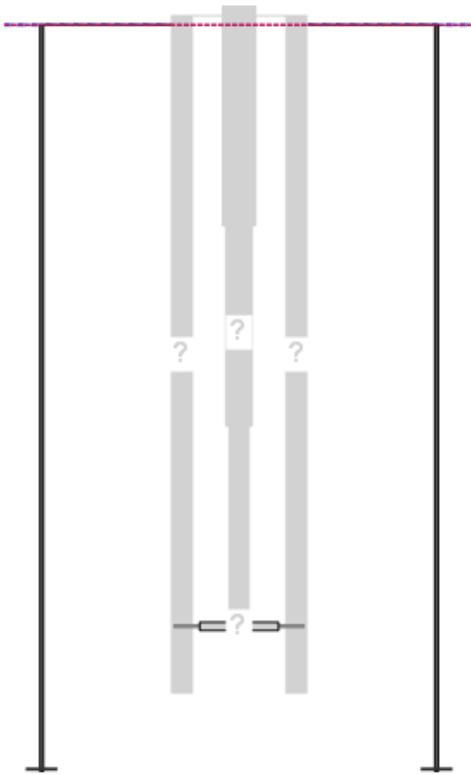

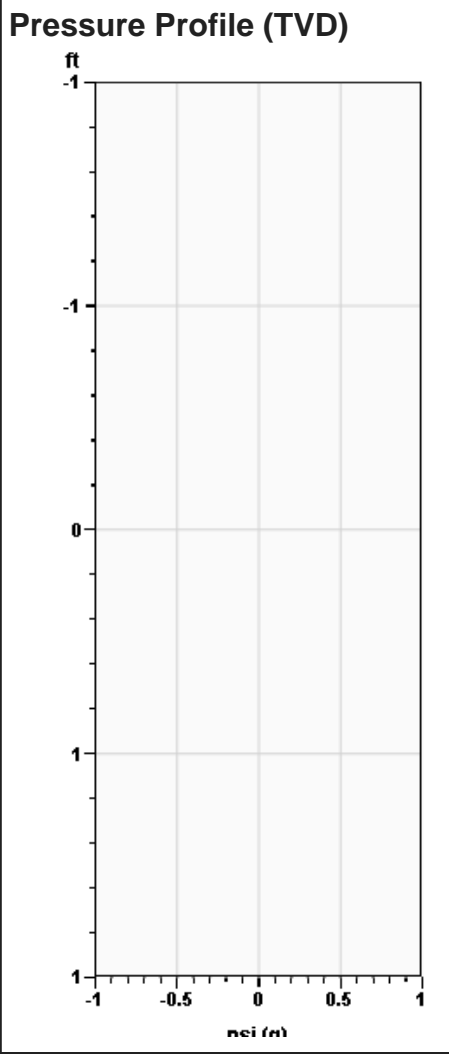
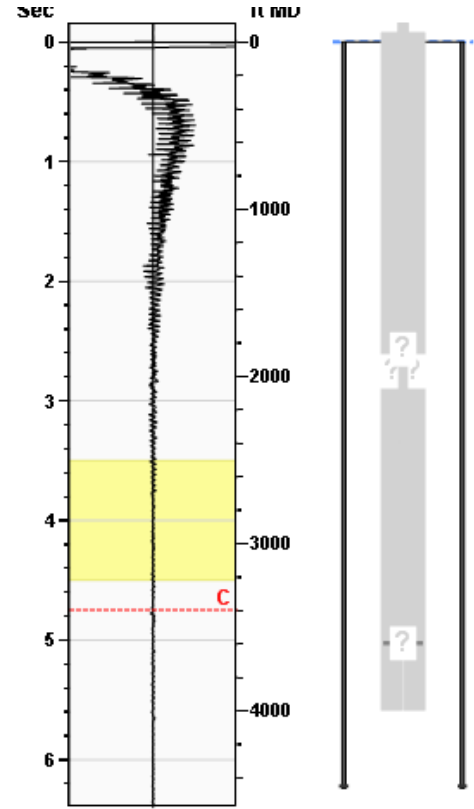


**Producing Shot

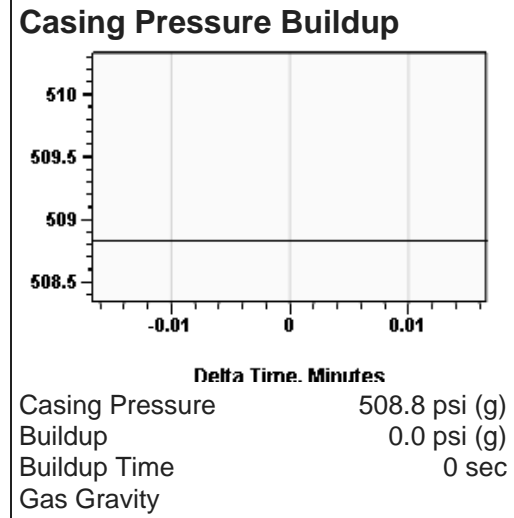
