

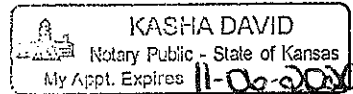



KNOW ALL MEN BY THESE PRESENTS: That,

WHEREAS, Donald L. Butler and David S. Butler, doing business as Double D Oil Company, Inc., a Kansas corporation, (hereinafter collectively referred to as "Double D") have heretofore used and occupied, and asserted ownership and control over, and responsibility for, the rights, wells, tank batteries and other equipment associated with the following salt water injection leases and agreements:

1. Salt Water Injection Well and Tank Battery Lease dated April 9, 2004 from Todd Andes, a single person, as Lessor, to Boomer Sooner, Inc., a Kansas corporation, as Lessee, covering the Southwest Quarter (SW/4) of Section 16, Township 32 South, Range 5 East, Cowley County, Kansas and Moon A 8 salt water injection well, recorded in the office of the Register of Deeds, Cowley County, Kansas in Book 717 at Page 109; and
2. Salt Water Injection Well Lease dated January 14, 1985 from Harold Moon and Veryl A. Moon, husband and wife, et al., as Lessor, to Exxon Corporation, as Lessee, covering the South Half of the Southwest Quarter (S/2 SW/4) of Section 16, Township 32 South, Range 5 East, Cowley County, Kansas and Moon Bros. 6 salt water injection well, recorded in the office of the Register of Deeds, Cowley County, Kansas in Lse. Book 250 at Page 359;

WHEREAS, Todd L. Andes ("Andes") is the current owner of all surface rights and oil, gas and mineral rights associated with the Southwest Quarter (SW/4) of Section 16, Township 32 South, Range 5 East, Cowley County, Kansas and the Lessor or successor in interest to the Lessor under the above-described salt water injection leases and agreements; and

WHEREAS, Double D, claiming to be the current owners and operators of the above-described salt water injection leases and agreements and all wells and other equipment and facilities located thereon or upon the land covered thereby, desire to terminate and release said leases and agreements, relinquish and surrender to Andes all rights associated with, derived from, or incident to the same, and assign and transfer to Andes all right, title and interest of Double D in and to the wells and associated equipment hereinafter more fully described.

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration paid by Andes to the undersigned, the receipt and sufficiency of which is hereby acknowledged, Double D does hereby release, relinquish and surrender unto Andes, his heirs, legal

representatives and assigns, said Salt Water Injection Well and Tank Battery Lease and Salt Water Injection Well Lease, disclaiming any further interest whatsoever therein or thereto.

Double D does further hereby assign, transfer and set over unto Andes all right, title and interest of Double D in and to the following-described wells, including all tubing, rods, casing and other associated equipment, located on the Southwest Quarter (SW/4) of Section 16, Township 32 South, Range 5 East, Cowley County, Kansas:

Moon Bros. 6 well, located in the Northwest Quarter of the Southeast Quarter of the Southwest Quarter (NW/4 SE/4 SW/4) of said Section 16; and

Moon A 8 well, located in the Southwest Quarter of the Southwest Quarter of the Southwest Quarter (SW/4 SW/4 SW/4) of said Section 16

which assignment and conveyance shall be effective upon abandonment of said wells by Double D, but not later than ninety (90) days following execution of this instrument as shown by the date of execution and acknowledgment of the signatures. Double D further agrees to remove and restore the site of a tank battery situated in the West Half of the Southwest Quarter (W/2 SW/4) of Section 16, Township 32 South, Range 5 East, Cowley County, Kansas pursuant to the terms of the aforementioned Salt Water Injection Well and Tank Battery Lease on or before December 31, 2019.

Conveyance of the foregoing wells and equipment is made by Double D in their present working condition, with no harm or damage caused by Double D, but otherwise without warranty of any kind, including warranty of quality, condition, or fitness for any particular use, express or implied.


