- 1) MIRM unseat pump POTH w/ rods. nu BOP & POTH w/ Tbg
- 2) PU 4 1/2" Tbg set CIBP. CATH, set CIBP @ 2577', release Tbg circ w/ mud & cap w/ 5 SKW POTH. Pull CBL to verify cement tops
- 3) Perf & Squeeze if no cement. If TOC above 983', spot plugs below.
- 4) Run Tbg & spot following cement plugs!
 - a) 2200' - 2100' - if covered by cement - 25 SKW Clay "C"
 - b) 1475' - 900' - 50 SKW cement
 - c) 200' - 4' - Perf & circ to surface - 55 SKW cement
- 5) ROSU cut & cap well.

Dear Sharon Sequera:

The Conservation Division has received your Well Plugging Application (CP-1).

Under K.A.R. 82-3-113(b)(2), you must notify DISTRICT 1 of your proposed plugging plan at least 5 days before plugging the well. DISTRICT 1's phone number is (620) 682-7933. Failure to notify DISTRICT 1, or failure to file a Well Plugging Record (CP-4) after the well is plugged will result in a penalty recommendation.

Under K.A.R. 82-3-600, you must file an Application for Surface Pit (CDP-1) if you wish to use a workover pit while plugging the well. Failure to timely file a CDP-1, failure to timely remove fluids, or failure to timely file Closure of Surface Pit (CDP-4) or Waste Transfer (CDP-5) forms will result in a penalty recommendation.

This receipt does NOT constitute authorization to plug this well if you do not otherwise have the legal right to do so.

This receipt is VOID after October 09, 2021. If the well is not plugged by then, you will have to submit a new CP-1 if you wish to plug the well.

The October 09, 2021 deadline does NOT override any compliance deadline given to you by Legal, District, or other Commission Staff. Failure to comply with any given deadline will still result in the Commission assessing penalties, or taking other legal action.
