## Day 1 and Day 2-Fish rods and tbg

1. MIRUSU, Unflange well. Spot 2 7/8 work string(2600') and 3/4 rod string (2600').
2. TIH with overshot with extension and latch onto tbg fish. Attempt to POH tbg. If tbg is not free. TIH with work rod string and attempt to POH remainder of rod string ~2050'.
3. Continue with fishing operations until rods and tbg are out of well. If unable to get all rods and tbg out of well contact KCC with issues.
4. Run tbg set CIBP and set @2590.
5. Trip tbg out, remove setting tool and spot tbg at 2590' on CIBP. Ready to pump cmt on plug.
6. If unable to get all tbg and rods out. May rig up wireline, cut tbg above freepoint or rod fish. Confirm plugging orders with KCC before cutting. Release wireline truck.
7. Spot open top tank for cementing washup.

## Day 3

1. If tbg is already spotted at CIBP, spot 5 sks cmt on CIBP to cover perms.
2. Pull up hole and spot 30 Sks cmt at 1800' to cover anhydrite.
3. Pull up hole to 1300' and spot 30 sks cmt with 100# cotton seed hulls.
4. Pull up hole to 700' and mix and pump 112 sks to fill 7" casing from 700' to surface.
5. POH and laydown tbg.
6. Top off both surface and production casings to ground level.
7. Shut down and washup into open top tank.

## Day 4

1. RDSU and dig out wellhead 4' below ground level and cap wellhead.

Dear Sharon Sequera:

The Conservation Division has received your Well Plugging Application (CP-1).

**Under K.A.R. 82-3-113(b)(2), you must notify DISTRICT 1 of your proposed plugging plan at least 5 days before plugging the well.** DISTRICT 1's phone number is (620) 682-7933. Failure to notify DISTRICT 1, or failure to file a Well Plugging Record (CP-4) after the well is plugged will result in a penalty recommendation.

**Under K.A.R. 82-3-600, you must file an Application for Surface Pit (CDP-1) if you wish to use a workover pit while plugging the well.** Failure to timely file a CDP-1, failure to timely remove fluids, or failure to timely file Closure of Surface Pit (CDP-4) or Waste Transfer (CDP-5) forms will result in a penalty recommendation.

This receipt does NOT constitute authorization to plug this well if you do not otherwise have the legal right to do so.

This receipt is VOID after October 24, 2021. If the well is not plugged by then, you will have to submit a new CP-1 if you wish to plug the well.

**The October 24, 2021 deadline does NOT override any compliance deadline given to you by Legal, District, or other Commission Staff.** Failure to comply with any given deadline will still result in the Commission assessing penalties, or taking other legal action.
